2. Guest Speaker

- a. President Haas
 - Construction/Facilities:
 - 1. Construction of new health sciences facility on Medical Mile is moving along, new construction plans are underway which includes a proposed new facility for computer information system programs.
 - 2. GVSU has had a lot of facility additions in the last few years that will help the university stay prominent and meet the campus's growing demands through the next decade.
 - 3. Through the planning process, we will continue to prioritize the maintenance of all our buildings; this is a strength at GVSU.
 - ii. Continue engagement in curriculum design:
 - 1. GVSU must continue to be relevant through our recruitment and retention processes. We must continue to fulfill commitments to admitted students so they can be successful in and out of the classroom. GVSU must continue to offer rigorous coursework so students can be challenged and successful at GVSU and in their fields.

- 2. Grand Valley has a similar admittance population to MSU yet they are more successful with retention. This is a goal area for GVSU.
- 3. Lake Effect Campaign with a fundraising goal of \$85 million, the campaign will address three primary areas of need (1) opportunity (2) achievement (3) relevance.
- Work continues on early preparatory coursework for incoming and transfer students, this includes, reverse transfer agreements with community colleges, etc.

iii. Other Updates:

- 1. The VP of Finance search is wrapping up as the committee has met with finalist and an offer will be made in January.
- 2. Re-accreditation, Grand Valley is working diligently for this so we will be prepared and successful next year.
- The question of expanding offered childcare services has been proposed many times. The university has continued to explore but challenges prevents expanding the center to include infant care. The addition of an Early Childhood academic major may help this in the future.

 - i. Concern was brought forth that the healthy choices program for single parents get less rewards as a dual parent household \$500 verse \$300
 - c. Parental Leave Women's Commission hoping to have a final document to put forward early next semester

 - a. With changes in the department, the chair and vice-chair (Rence and Samantha)
 will serve as liaisons to the university public safety committee as
