- 1. The meeting convened at 3:00 pm.
- 2. The minutes from the September 1st APC meeting were approved as written.
- 3. The appointment of Jarrett Martus to fill the vacancy in Group Six's representation on the APC was unanimously ratified.
- 4. Group discussion with the Salary & Benefits Subcommittee.
 - a. Items for discussion with the S&B Subcommittee included the following:
 - Pending changes in the Fair Labor Standards Act (See Minutes from Sept. 1 meeting), how affected personnel will be contacted, how we will come to compliance, and the role that the APC and S&B will play as the situation unfolds.
 - Advancement opportunities for AP staff members—paths for promotion that are equitable across all units/divisions. The S&B has looked into this question and explored what colleges and divisions do about this as an issue. They found that there is not a uniformed process across the university.
 - The use of ePDP as both a tool for both professional development and performance review, and the challenges such a dual purpose creates; also the degree of influence of performance reviews on salary increases.

Discussion was lively and yielded a list of questions that Colleen Bailey, Michelle McCloud, and Rence will present to Dev Butler, with a request for responses by our next regular meeting, scheduled for November 3rd.
