

IF YOU FEEL YOU ARE A VICTIM, CONSIDER THESE FIRST STEPS

Get Help

- Get to a safe place as soon as you can.
- If you believe you or anyone else is in immediate danger, call 911 as soon as possible.
- Once you are safe, contact someone you trust to be with you for support.

Get Medical Attention

- Seek medical attention as soon as possible.
- Medical attention may be necessary to mitigate the risk of sexually transmitted diseases or pregnancy.
- Even if you think you are physically OK, you may have injuries that need treatment.
- Forensic evidence can be collected if criminal action is desired or may be desired in the future.

Preserve Evidence

- Evidence may be used to provide proof of criminal activity or in obtaining a protection order.
- Evidence is best collected as soon as possible or within 120 hours of the assault.
- Medical and/or law enforcement personnel can assist with evidence collection and preservation.
- If you choose not to make a police report, you should still consider preserving evidence in the event you change your mind at a later date.
- Seek counseling support from one of the on-campus resources or in the community.
- Remember that self-care is an important part in coping with the event.

Consider Reporting the Incident

- Contact campus or local law enforcement.
- File a Title IX complaint. University authorities will assist in notifying law enforcement if requested.
- Contact the campus victim advocate.

HERE TO HELP

PROTECTIVE MEASURES

Grand Valley recognizes all valid orders of protection including cease and desist, no contact orders, personal protection, or similar lawful orders. If you have a valid order, please inform GVPD to receive appropriate services. The university can provide protective measures for the complainant in the form of changes in academic or living situations, counseling, and no contact orders.

UNIVERSITY DISCIPLINARY PROCESS

The university disciplinary process includes a prompt, fair, and impartial investigation and resolution process. Investigators are trained annually on the issues related to domestic violence, dating violence, sexual assault, and stalking, and taught how to conduct an investigation that protects the safety of the complainant and promotes accountability.

SANCTIONS

The Dean of Students Office may impose sanctions on the respondent following a final determination of a Title IX investigation for sexual assault, dating violence, domestic violence, or stalking. Sanctions include formal reprimand, disciplinary probation, restriction from employment at the university, restorative justice project, university housing transfer or removal, professional assessment, removal from specific courses or activities, removal or nonrenewal of academic scholarship, no contact, restitution, suspension, or expulsion from the institution.

Sexual assault, domestic violence, dating violence, and stalking may be found to be criminal acts, which may also subject the respondent to criminal and civil penalties under federal and state law.

INFORMATION CONFIDENTIALITY

The university will work with you to protect your privacy by sharing information with only those who need to know. You should discuss your desires regarding the sharing of information with any university employee with whom you speak, to ensure you understand their reporting obligation and what information they may be required to share.
