4. Unfinished Business

- a. Structure
 - i. Proctor: EVP Hallead, Cabinet, and I took the suggestions regarding our executive branch. We are pretty in favor of adding another executive position, we would have the President who is the external, Parliamentarian who is the internal and the Vice President who is the bridge in between the two. Then the Judicial Branch, we decided that the Parliamentarian would be the chair of this Judiciary Committee. To be appointed, these people would be interviewed by the Executive Branch, then would have an interview every year as a check in. You could serve all four years and their job is to ensure the governing documents of Student Senate are being honored, they also would be responsible for creating policies and procedures for the spring elections.
 - ii. Bartlett: Could a senator request to become a part of the Judiciary Committee if they are a current senator?
 - iii. Proctor: Yes but they cannot serve on both.
 - iv. Hallead: If there is no interest for these positions, you can interview and this would serve as your "University Committee". We will get into this later.
 - v. Proctor: We are just going to go straight into a vote. Any more discussion on this?
 - vi. TerHorst: Do we include representation of the colleges in this?
 - vii. Proctor: That will be the next proposal.

- b. Representation
 - i. Proctor: We would have 40 total seats in our representation models. 20 representatives for our at-large seats, 4 Freshman, 1 International Student, and the rest would be proportionally spread out throughout the colleges. This would change every year but here is an example of what this would look like right now with the current number of students per college. Is there any discussion on how we divided the 20 seats?
 - ii. Martinez: For the 4 freshman seats, if there were more would they just go into the other seats?
 - iii. Proctor: Yes.
 - iv. Palumbo: If no one filled these reserved seats, would it become an at-large seat?
 - v. Proctor: Yes, I will add that to the proposal.
 - vi. TerHorst: Would this be at large for graduate students as well? Would this be how all senators are elected?
 - vii. Hallead: At-large seats would be the same way we elect right now, but graduate students have their own senate called the GSA.
 - viii. Proctor: Any more discussion, ok. We will move down to elections. For the executive elections, option one would be the direct election of the president by the students, the other would be senators would elect the president.
 - ix. Stang: Did we discuss splitting up the vote?
 - x. Hallead: Yes we did, but there were a lot of logistical issues that wouldn't make this work.
 - xi. Bartlett: Having students vote, it might make it a popularity contest. Senators know who is working and people might not have a good perception of who is working behind the scenes.
 - xii. Bennett: I agree, is the president currently elected by the body?
 - xiii. Proctor: No.
 - xiv. Hallead: I don't mind either one, but I do like the first option a bit more. If we were to do it this way, there are provisions like serving on the senate for 15 weeks. I don't think we would have an issue with someone who isn't qualified.

- xv. Hazari: I feel we are trying to get more people involved. If we have people representing the colleges we will get more engagement. I feel we have done a great job putting a great person in the position of President and EVP and as someone we trust.
- xvi. Proctor: I think there are pros and cons. Like EVP Hallead said, I want the first option.We will get more student engagement. Cons would be that the senate would know better than the student body of who is qualified.
- xvii. Hallead: If you are running for elections, you will be able to vote for whoever you want anyway.
- xviii. Rienas: When we are talking about this. In this process, making this president entirely external and if they are representing the students. The students definitely need to have a voice.
- xix. Martinez: I also agree with option one, it will make the student body want to be involved and it will be fun to have election nights.
- xx. VanDyke: Option one is a good choice and I think the best.
- xxi. TerHorst: I think if we did this they would have to serve on the Student Senate for one year.
- xxii. Gessler: I agree with everything Senator Rienas said.
- xxiii. Burns: I think the students should be involved but how are they supposed to know if the senator does their work.
- xxiv. Proctor: This is an important issue.
- xxv. Martell: I thought last week at cabinet we carved out the requirements to be on the ballot.
- xxvi. Hallead: The requirements are the senator must have been on the body for at least a semester and is in good standing within the senate.
- xxvii. Martell: I would have to agree with option one if we want to expand. If we just let the senate vote it will stifle us.
- xxviii. Jean-Pierre: Maybe we could require someone to get a certain amount of signatures from the senators and make that option work.
- xxix. Rienas: We have rules set up if someone isn't doing a good job. Since we have another position to make the president's role external. Even if they got elected because they are popular, it doesn't matter because it's an external role.

- xxx. Hazari: When we talked about the hybrid, if we talk about signatures, would it be the new body or old body that those signatures would come from. The public still has a say they can contribute to our elections and speak what they think at public comment.
- xxxi. Bashore: What if we do have a President who isnt very good, do we have a process in case we can fix this?
- xxxii. Proctor: We have an impeachment process.
- xxxiii. Bates: In my sorority we do slate candidates. We are able to see which senators reach those requirements and I know we are typing to lessen the amount of work but I still like the idea of us voting on candidates.
- xxxiv. Proctor: I like the signatures, this part will come back next week, I am going to entertain a strawpoll. Option one is direct votes by students and second option is senate votes.
- xxxv. Proctor: Appointments: there would be 4 seats reserved for freshmen, we decided to go forward by doing it how we did it this year by doing it all at once. The executive branch determines the forms and amount of interviews. We also reccomend that they attend one GA before an interview. We would try to take an objective approach and a holistic approach to be sure to get a diverse prerspectie.
- xxxvi. Johnson IV: Can you go into the timeline in selecting new senators into the regular seats and judiciary branch?
- xxxvii. Hallead: At-large seats would be hopefully appointed by the second GA and judiciary around the same time hopefully.

- xxxix. Martniex: Is this process the same for all seats?
 - xl. Hallead: We would want all seats to be filled for elections, but if we didn't fill them, then we would use this process.

 - xlii. Proctor: We have a commission of members who are not running for relection so that's why the parliamentarian would be excused. We will still come back and touch on this next week.

6. New Business

- a. Division of Labor
