- xiv. Johnson IV: In regards to the misconduct, where is this held? Will it be archived?
- xv. Hallead: The record is in the minutes as it is revealed in GA.
- f. Shared Governance
 - i. Proctor: Does anyone know what Shared Governance is and why it's important? Shared Governance is how students, faculty, and staff all participate in the development of policies and in the decision-making processes that affect the institution. It addresses the overall quality of academics at the university level and the related components that affect life at the university. Shared Governance allows University to more directly receive input and feedback on what is best for the campus community. It is how we communicate, collaborate, and connect about the things that are important to overall university life/ Examples:
 - 1. Student Senate passes legislation as the voice of the students.
 - 2. Senators communicate with stakeholders about issues on campus, and potential solutions to them.
 - 3. Faculty governance which includes the University Academic Senate (UAS), this is similar to the General Assembly of Student Senate, as well as the Executive Committee of the Senate (ECS), which is similar to the Cabinet of Student Senate. I am a voting member of both UAS and ECS, serving as the voice of the students in faculty governance.
 - ii. Proctor: Hallead and I also attend President's Council to serve as the voice of students for President Mantella's Reach Higher 2025 initiative. We also attend Board of Trustees meetings as requested. There are a few executive responsibilities, the president and vice president will attend UAS/ECS, attend President's Council and Board of Trustees meetings as requested. University Committee requirements will be at the discretion of each year's Cabinet. It has been somewhat difficult to get Senators on University Committees in a timely manner, so we wanted to allow the future to make decisions that work for them, although we encourage participation in University Committees. We would move University Committees to the Vice President, it's a lot of administrative work that we can balance with an expanded Executive Branch. I will work with Dr. Felix Ngassa and Lisa Surman to see if we can streamline the process in the future. The legislative process will look largely the same, but the Judiciary Committee will check for grammar and formatting, but not content, to free up some time for Cabinet.
 - iii. Johnson IV: What is the main intent for feedback from General Assembly?

iv. Proctor: For the first presentation, Senators can bring suggestions that may improve the legislation. This creates more buy-in and improves the quality of legislation, making it more likely to be passed and implemented. Legislation can be voted on at the second GA it is presented at, following discussions on any updates. There aren't too many changes to amending the Constitution. We shortened the process to only need to be presented at two GAs rather than three. There wasn't much to discuss the third time for my amendment last year. I am going to add that it has to be a ²/₃ majority vote of senators to pass a Constitutional amendment. The rest of the governing docs, including the bylaws and policies and procedures can be amended or suspended by a ²/₃ majority of GA. We are also proposing that Cabinet can temporarily suspend sections, or all of these governing documents by a unanimous vote. This would have to be voted on at the next GA. This is in case we run into barriers that need to be immediately addressed, like we faced at the end of last April. This will be tabled until the next GA, before we advance it to the omnibus.

g. Miscellaneous

- i. Hallead: For awards, this will be the same as it currently is.
- ii. Proctor: We will start this process very soon, but Student Senate does vote to give an award to a faculty member. I will be sending you guys a nomination form, if you see any faculty that may deserve it. They will be invited to the President's Ball, they will be one of our last lecture presenters.
- Hallead: The criteria for President Emeritus is 3 years on senate, 6 academic semesters, 1 in a cabinet role, 3.5 GPA or higher, and serve as President. This goes to very few individuals and is very prestigious.
- iv. Bates: Why such a high GPA requirement?
- v. Hallead: It's to set a high standard.
- vi. Martinez: Would it be possible to change the GPA to a 3.0 rather than a 3.5. I feel that if someone does all of this, it might be hard to keep a GPA up if you are this busy.
- vii. Johnson IV: How do you evaluate merit if those aren't met, how can we say someone is valid in their role but they dont get an award.
- viii. Proctor: I think it was supposed to be by design.
- ix. Bates: You could be a great president and not be good academically.
- x. Proctor: This will be tabled for the next meeting as we will vote at our next meeting.

- a. Conduct Review Proceedings
 - i. Proctor: For this I am going to hand it over to EVP Hallead.
 - Hallead: November 5th, we held a Conduct Review Proceeding. Yash Hazari was conduct reviewed, we need to vote to approve the results, due to precedent. I am going to read the charges: Breach of the Fall 2023 Code of Conduct, Breach of the Constitution or Bylaws, Violation of the Senate Resources Policies and Procedures, or previous sanctions as set forth by the Conduct Review Board or the Senate Resources Committee, Committing actions unbecoming of your office, Misconduct, including: Office misconduct, Inappropriate behavior at Senate-related events, Defamatory acts towards the Student Senate. The board unanimously voted to remove him from Student Senate indefinitely.

 - iv. Hallead: Yash Hazari, we are going to go into a vote. Approval of Removal of Yash Hazari from Student Senate indefinitely.
