#### **Glen Mills**

Founded in 1826, the Glen Mills Schools (GMS) is a school of opportunity where youth can be transformed into positive and contributing members of society. GMS provides rehabilitative services to adjudicated male delinquents between the ages of 12 to 18. All programs are aligned with Juvenile Justice System Enhancement Strategies (JJSES) and the Balance and Restorative Justice (BARJ) model. Located in suburban Philadelphia on an 800 acre campus, it is the oldest continuously operating school of its kind in the United States.

The Glen Mills Schools provides a year-round education model. They utilize a blended learning approach to instruction that incorporates the Plato Learning Environment computer software, allowing for individualized academic coursework. All students are assigned a computer. GMS students can earn their GED or high school diploma and scholarships are available for post-secondary study.

GMS provides students the opportunity to earn four levels of certifications based on industry standards in each of the 25 Career and Technical Education (CTE) areas. Some of the areas offered are Auto Body Repair, Automotive Technology, Building Trades, Masonry Residential Carpentry, Small Engine Repair, Welding, Barbering, Culinary Arts, Golf Course Maintenance and Management, Dental Assistant, Opticianry, Photography and Graphic Communications and Print Technology to name a few.

GMS is a member of the Pennsylvania Interscholastic Athletic Association and the Delaware Valley Athletic Association. This gives students the opportunity to participate in over fifteen varsity and junior varsity high school sports.

GMS offers evidence based programs such as Botvin LifeSkills, Moral Reconciliation Therapy, Coping with Anger and Parenting & Family Values. As well as competency based programs, Drug and Alcohol Education, Gun Violence Prevention and Independent Living Skills. GMS also offers an intensive outpatient substance abuse program by request.

GMS provides a parent visitation program where they will fly parents out to GMS to visit their sons.

#### **Highfields, Inc.**

The Holy Cross Services family is made up of: child & family welfare services; substance abuse and mental health services; and a community resource center called The Samaritan Center on the east side of Detroit.

Holy Cross was founded nearly 70 years ago and has a mission to bring hope, promote change, and help children and adults live free, healthy and productive lives.

#### **Lighthouse**

For mariners, a lighthouse often represents a beacon of hope when they have ventured off course. A lighthouse is also a critical guide when charting a careful return to port or departure to sea. The 20th Circuit, Juvenile Court Lighthouse Program is a secure residential treatment for girls, to offer hope in discovering a deliberate, viable, charted course for their futures. Located in the American Correctional Association accredited Ottawa County Juvenile Detention Center, Lighthouse is a short-term residential treatment program. The program is open to females ages 12 to 17 under court jurisdiction. The focus lies heavily on stabilization and therapeutic support, Lighthouse individualizes programming to meet the needs of the girl and her family for a successful and safe journey back into the community.

#### **On Trac**

On Trac Residential Treatment Services seeks to Transform young men by tapping into their creative energies, Respect them by acknowledging their potential, hold them Accountable for previous choices, and give them the Courage to change and make new choices.

On Trac Treatment Services combines therapeutic and correctional approaches to behavior management to instill lasting change in our program participants. We utilize cognitive behavior therapy; trauma focused counseling, and various intervention and recreational groups to promote family and individual strengthening. On Trac also offers vocational training in the areas of screen printing and culinary arts. The foundation of On Trac Treatment Services is based on an evidenced based model referred to as Moral Reconciliation Therapy (MRT). MRT is a systematic treatment strategy that seeks to decrease recidivism among juvenile and adult criminal offenders by increasing moral reasoning. Throughout their time in the treatment program minors will focus on the various steps of MRT while making positive changes in their reasoning and behavior moving towards program completion. Youth risk factors and stages of change are closely monitored with a comprehensive evaluation and treatment plan. On Trac strives to provide youth with quality educational, recreational and vocational training while they are engaged in our services. There is a strong emphasis on creative and artistic outlets as a means of expression and healing inherent throughout the program. On Trac Treatment Services offers a secure setting that promotes community safety and rehabilitation while providing services to our young men.

#### **Safe Harbor Adolescent Recovery Program (SHARP)**

SHARP, is a court-administered, co-ed, adolescent substance abuse treatment program offering all phases of treatment: stabilization, assessment, treatment and transition services. This is a collaborative approach with treatment providers, Charlevoix Public Schools and court licensed foster providers. This “least restrictive” style of in-patient services accessible through an Intensive Out-Patient arena enables a cost reduction by ½ as compared to the State approved rate for In-Patient programming.

Charlevoix County Probate/Family Court will coordinate all referrals and placements into our program. The per diem rate for this program is \$160.00.
