***COURSE DESCRIPTION***

This class is designed to provide education and practice strategies for establishing rapport, gathering information, conducting assessment, modifying delinquent youth's emotional state and maladaptive behaviors, assessing suicide risk and making referrals. Specific techniques, in addition to understanding specific counseling paradigms used with resistant and delinquent youth, will be explored.

***COURSE OBJECTIVES***

By the end of the course the student will be able to understand a number of services for juvenile offenders including:

- direct counseling and casework services
- interviewing and collecting social service data
- making treatment recommendations and report writing
- maintaining working relationships with youth, families and the community
- using community resources, providing specialized services such as group work, behavior modification counseling, reality therapy, cognitive intervention, and suicide assessments
- supervising specialized caseloads involving children on drugs or with special psychological or emotional problems

***LEARNING EXPERIENCES:***

Lectures, assigned readings, class discussions, experiential activities, case studies, videotapes, guest speakers, and in-class and out-of-class written work constitute the major learning experiences in this course.

## ***COURSE REQUIREMENTS***

Students are expected to read the required readings prior to each class session, to attend class, to participate in class discussion and group activities, and to satisfactorily complete the written assignments.

## ***ASSIGNMENTS***

1. Students are encouraged to make every effort to attend all sessions. There will be a flexible 1 class absence granted for each student if notice is given prior to class; attendance points will be deducted at the rate of 20 points per class. Lack of participation, late arrivals and early departures will each result in point deductions.

2. Each student will be required to complete 3 assignments which will include preparing a hearing report, and research of a variety of agencies as well as institutional placements. The assignments are designed to increase your knowledge of community resources, specialized therapy, and experience with making treatment plans. The assignments will be discussed and then handed in according to the class schedule listed below. Each assignment **MUST BE TYPED**. (12 point font, and Arial, Times New Roman or CG Times...1 inch margins)
