# **Policies for On Campus Suppliers**

Smoking

Smoking is prohibited in all indoor spaces. Smoking is prohibited within 25 feet of any GVSU building or bus stop.

## GVSU RFP #218-04: Specifications

GVSU is open to design ideas for the wall but generally this is what we have in mind:

Removal and disposal of the existing home-run black chain link fence, and its top and bottom rails is required. The supplier may choose to use the existing home-run fence poles for the new wall or remove them.

The new home-run wall must be a solid 8-foot tall wall built out of treated plywood (4' x 8' x  $\frac{3}{4}$ "). Wall height should be a uniform 8' tall. All lumber must be treated.

Yellow vinyl top cap along entire length of wall

The landscaping must be returned to its original condition.

Supplier may quote on the painting of the wall as a separate line item. GVSU might or might not include painting in the award of this RFP. Color will be black.

GVSU will be responsible for the on-going maintenance of the wall.
