  quotations will be accepted. Please indicate RFP #217-31 on your envelope or package. Grand
  Valley State University is not responsible for late, lost, misdirected, damaged, incomplete, illegible
  or postage-due mail. Provide two hard copies of your proposal.
- 2. Should it become necessary to revise any part of the RFP, notice of the revision will be given in the form of an addendum to all prospective suppliers on record as having received the RFP. Any addendum notices will also be posted on the <a href="Bid Opportunities">Bid Opportunities</a> page of the GVSU Procurement Services website <a href="www.gvsu.edu/purchasing">www.gvsu.edu/purchasing</a>. Each supplier should acknowledge receipt of addenda in their proposal, but the failure of a supplier to receive or acknowledge receipt of any addendum, shall not relieve the supplier of the responsibility for complying with the terms thereof.
