- a) **Requesting Organization:** Campus for Consent

**Title of Request:** Winter Training & Domestic Violence Meeting

**Date of Activity:** 2/20/2018

**Name(s) of Presenter(s):** Madison Brooks

**Amount Requested:** \$243.20

**Amount Allocated:** \$151.60

**Narrative description of presentation/discussion and details on what was approved or unapproved in the request:** Funding is being requested for a training for the Campus for Consent group and for any member of campus that wants to attend. It was clarified that the training for February 3<sup>rd</sup> no longer would be on. Line items 1 and 2 can be cut immediately because the date is irrelevant. The group went on to talk about the promotions for the event, and the board suggested even adding a line item for these promotions. The group explained that they have printed flyers for the event on their own. The board also brought up the size of the room, where only 20 people would fit. The board suggested possibly renting a larger room if they expect that many students to attend. The board also suggested potentially working with other departments and/or organizations in the future.

VP Aller explained that at first, she thought this was just a training for the members of the club, but in reality it is a training for the entire campus. The board decided to help the group out by giving them a promotions package for pluggers and a plasma add, which would be \$50.

**Narrative description of presentation/discussion and details on what was approved or unapproved in the request:** Funding is requested to support a survivor awareness event. The counseling center offered \$200 to aid the event, and the OMA also told this group that they would support the event, but they wanted the group to put in a request first. VP Aller explained that the board cannot fund giveaways. She went on to explain that the board could help the group with many costs, but not the t-shirts. The board explained that they can help fund some supplies for the creation of the t-shirts, but not the t-shirts themselves. The board asked if these supplies (such as tarps, table cloths, rubber bands, ect.) could be reused. The group explained that they have looked at Meijer for supplies and dollar stores and these are the most competitive prices. The new total considering the rules of the committee, including rounding up all of the totals would come out to be \$106.00

The group explained that the group will be paying for their own vans with their own money, as well as money from the Career Center. The group assumes that there will be about 15 members in attendance. 2 of these people will be staying in the Nationals' rooms, but they are still looking at taking one van. Confirmed, they have 12 students. The board went on to break down the numbers within the request, and found that \$4071 would be the amount that the board could consider funding. Half of this amount would be right around the \$2000 mark.

**Narrative description of presentation/discussion and details on what was approved or unapproved in the request:** Funding is being requested for a \$55 CPAC ticket, for 21 college republicans to attend, as well as lodging for all of these students. This lodging however encompasses \$80 deposits on the rooms, however, these rooms would come out to be free, and students would get this money back. The board questioned if this would be acceptable or not, seeing how it is not a simple room payment. Krista came in to discuss the details of the deposit, and confirmed that it could be done. The board asked about specific transportation costs that the group is looking at in order to decide upon the halfway point for funding purposes. With the plane requests, the amount for

the trip would be over \$4000, and that would allow the group to fund the \$2000 cap amount.

After the motion was made, the consideration was made that funding this much would not account for the total \$2000 because it would come out to be a wash-the group would actually only be credited roughly \$300. However, with constraints of this fiscal year and being unable to reallocate this back to other student orgs in time, the board did feel as though they were properly enabling the group to go to this conference.
