4. Description of Request: Holding a conference for Universities Allied for Essential Medicine, we are looking to offer hospitality to guests attending. As this is a longer event, we are looking for funding for a standard conference breakfast (coffee, juice, water, light snacks) as well as lunch (pizza and tossed salad). We
