**Narrative description of presentation/discussion and details on what was approved or unapproved in the request:** Funding is being requested for a “How Deep are your Roots” event which will take place on campus in February. **Amount Requested:** \$2331.75

**Amount Allocated:** \$1756.75

**Narrative description of presentation/discussion and details on what was approved or unapproved in the request:** Funding is being requested for an annual kpop event on campus. Funds are specifically being requested for food service, a DJ, Tanner Priest, the dance floor rental, a photo booth for the event, a filmographer, and a photographer. The board explained that they are unable to fund students at GVSU to film/photograph and event. Because of this, the DJ and the filmographer both could not receive funding. Valerie explained that if GV provides a service (like photographers). If the board funds this amount, the group would be able to either use the money for the GV photographer or it would be absorbed back into the student life fund. The board then called into question the merit of having a photo booth and also a photographer. Typically, the board does not fund photoboosts in general. The board commented that the promotions looked great, and completely fundable, and they looked into what cuts could be made to accommodate the changes they proposed. The board came up with \$1756.75 as a new total
