SESSION DESCRIPTION	Throughout the 20th century, sport was a catalyst for social and racial integration. But that integration was not without blowback - immense, violent, coordinated. The Civil Rights Acts and Title IX changed the landscape for sport in the United States and around the world. In this 21st century, the new frontier - in regards to civil rights, Title IX and with sport - is robust and stabilized integration for transgender and non-binary athletes. While support for the LGBTQ community broadly has never been higher, we are experiencing immense, violent, coordinated attacks on the civil rights, Title IX protections and access to sport (and other school-sponsored programs) for trans and non-binary communities. In this interactive workshop, participants will engage with foundational terminology, gain important understandings of the tenuous policy landscape, and leave with concrete action steps/skills for advocacy

What students experience today

HRC and researchers at the University of Connecticut found that:


- 80 percent of LGBQ teenagers and 83 percent of transgender teenagers are not out to their coaches;
- 41 percent of transgender boys, 34 percent of transgender girls and 31 percent of non-binary youth never feel safe in the locker room;
- Only 24 percent of LGBTQ youth say they play a school sport, compared to 68 percent of a national non-LGBTQ sample.
