

NEW TRANSFER STUDENT ORIENTATION

As a new transfer student at Grand Valley State University you are required to sign up for an Orientation session in order to schedule your classes. There is a nonrefundable fee due upon sign up.

Now that you are admitted, please watch your email for more information about Orientation.



During your Orientation session, you will meet individually or in a small group setting with an

academic advisor from your area of study. You will select and register for your Grand Valley classes and learn more about services and resources to help you succeed at Grand Valley. In addition, you will receive information on how your previous college coursework will transfer into your GVSU program of study. Please be sure that we have the most current transcript on file before you attend your Orientation session. This helps us provide the most accurate advice on an appropriate schedule of courses for the coming semesters.

All the majors available at Grand Valley are organized into seven different colleges:

You will work with an academic advisor from the appropriate college for your major. Students seeking a degree in education will meet with an advisor for their teachable major in the College of Liberal Arts and Sciences. HOUSING



Submit housing application (if needed).

We recommend that transfer students live on campus for at least their first year as a Laker. Staying with us will ease your transition to a new campus, and you will create greater connections

at Grand Valley with live-in staff support and residential programming. Additionally, you will be conveniently close to classes, advisors, dining, and recreation spaces; you're always home when you live on campus. When living on campus, all living expenses are included in the rate; you manage one consolidated bill, making your time at Grand Valley as smooth and simple as possible. ELECTRONIC BILLING

Students will be notified by email when new charges have been added to their account or when a monthly payment becomes due. If the student provided a parent email address, they will also receive notification. The student's Network ID and password are required to view any financial information. If the student set up proxy access for a third party, they will be able to review the bill and make payment with their email and PIN.

MTA AND MACRAO

Students who transfer with the Michigan Transfer Agreement (MTA) or the MACRAO agreement have satisfied the Foundations categories of the General Education Program and one Supplemental Writing Skills course. Transfer students with the MTA or the MACRAO are required to complete one Supplemental Writing Skills course in their major or division. In addition, transfer students with the MTA or the MACRAO must also fulfill the following general education requirements: a two-course Cultural Emphasis requirement and a two-course Issues requirement.

TRANSPORTATION SERVICES

GVSU offers transportation services ranging from carpooling to transit services. GVSU provides daily bus service between the Allendale Campus, Robert C. Pew Grand Rapids Campus, Health Campus, and the surrounding area. All GVSU and The Rapid transit routes are free to current students, faculty, and staff with a valid Grand Valley ID card.

FINANCIAL AID INFORMATION



Financial assistance is available to eligible students from a variety of sources. Financial aid can include institutional scholarships based on academic performance or other exceptional abilities, as well as

federal and institutional grants, loans, and work study. To be considered for these types of aid, students must file the Free Application for Federal Student Aid (FAFSA). Students interested in receiving financial aid at Grand Valley should file the 2024-2025 FAFSA by March 1 for maximum consideration for grant and scholarship aid.

Grand Valley has an outstanding merit-based scholarship program. Transfer merit scholarships are awarded based on cumulative college grade point average. Consideration for scholarships is based on a complete admissions application submitted by March 1 for spring/summer admission, July 1 for fall admission, and November 1 for winter admission.

GVSU also offers a scholarship matching database called myScholarships to help admitted students match with GVSU donor and department-specific scholarships. MyScholarships also gives students access to more than 10,000 external scholarship opportunities. These scholarships vary and may be based on interests, academic performance, special talents, major, and more. The majority of GVSU scholarship deadlines fall between January and March 1, while external scholarship deadlines vary year-round. Students may search and apply for these scholarships each year through gvsu.edu/myscholarships.

VETERAN AND MILITARY SERVICES

The Military and Veterans Resource Center provides support services and resources to active duty service members, military veterans, guards/reservists, spouses, and family

members. With a single point of contact serving militaryconnected students, our goal is to ensure we connect student veterans and their families to relevant resources, address emerging issues, and provide the necessary information to help them succeed. Some of the services we offer include:

DISABILITY SUPPORT RESOURCES

Disability Support Resources (DSR) in the Division of Inclusion and Equity strives to educate the campus community on disability issues to cultivate a more inclusive and equitable campus. DSR provides support services and accommodations that enhance the learning environment for students with documented disabilities. DSR promotes a broad definition of diversity that appreciates disability as an integral part of the academic experience.

DSR collaborates with students, faculty, and staff to promote equal access to the campus community that meets the needs of students with disabilities, fosters student independence, and recognizes students based on their abilities rather than their limitations. These practices help to identify innovative approaches and resources that support a diverse range of abilities and opportunities while maintaining compliance with the Americans with Disabilities Act (ADA) of 1990. DSR encourages the university community to

empower students, enhance equity, and provide a platform for innovation and inclusion.

Students should register with DSR as soon as possible after admission to the university to ensure the timely provision of accommodations. Advisors can also assist students with disabilities with questions regarding course selection, scheduling, and exploration of their areas of career interest. If a student requires more comprehensive services in these areas, advisors can refer students to other on-campus resources. Some available services include alternative format textbooks (if alternative books are unavailable), alternative testing, assistive technology, learning skills assistance, and transportation on the Allendale Campus. DSR also strives to educate the campus community on disability issues to cultivate a more inclusive and equitable campus for the benefit of all.

PARKING PERMITS



Parking your vehicle on the Allendale Campus, Pew Grand Rapids Campus, or Health Campus requires a parking permit. Permits are available to

purchase at **gvsu.edu/parking**. The permit costs \$240 per semester for those commuting to campus and enrolled in seven or more credit hours. For commuting students with fewer than seven credit hours, the permit cost is \$150 per semester. For students living on campus in GVSU housing, parking permits are \$210 per semester. The cost of the permit will be billed to your student account.

Students with classes at the GVSU Health Campus now have a parking option in the 335 Michigan shared parking ramp located northeast of the Daniel and Pamella DeVos Center for Interprofessional Health. A commuter or resident permit is required.

In addition, temporary day permits are available for purchase online at a cost of \$10 per day and will be billed to your student account.

Pay-to-park short-term options are available on each campus and can be found on the Parking Services website.

Parents and guests may obtain a visitor parking permit free of charge by visiting Grand Valley Parking Services, which has two locations: the north end of the Allendale Campus in the Service Building or on the Pew Grand Rapids Campus located at 102 Eberhard Center.
