# What are the expectations regarding internship/field placement during the COVID-19 crisis?

Students from the Public, Nonprofit and Health Administration program (PNHA) may be actively engaged in either paid or unpaid internship, while following all safety protocols of the specific site and the CDC guidelines. Students should pursue and continue internship hours as scheduled unless the site is experiencing a closure, or the student is experiencing an inability (with necessary documentation) to complete the internship expectations.

Due to certain health conditions or worksite protocol within my internship/field setting, I do not feel comfortable with the assigned work site or arrangements for my current placement. What should I do?

If a need arises to seek assistance for a specific concern, students are asked to first contact the site supervisor, followed by the **PNHA Internship Coordinator** to discuss directly. If additional assistance is required or mentoring is needed, please contact **Dr. Raymond Higbea**, School Director at (616) 331-6575.

My internship/field placement supervisor notified me that the agency is uncertain about or cannot have me working onsite. They offer remote work instead. How should this situation be handled?

Students will need to work with their **PNHA Internship Coordinator** to develop a plan for remote learning and supervision. If you have any concerns about the extent of remote learning, please notify your internship coordinator and/or school director.

The **PNHA Internship Coordinator** will make every effort to help you with either a re-assign internship location and/or come up with an alternative plan for internship completion.

## What are the expectations regarding internship/field placement during the COVID-19 crisis?

Students within the HTM program secure their own internships and agree/negotiate with an onsite supervisor regarding start/end dates, hours, expectations etc., in conjunction with the course syllabus. Each field experience is a 2-credit course and a minimum number of hours are required (300 for HTM 290 & 390; 400 for HTM 490). The hour requirement is flexible to 75% [of this requirement] during the COVID-19 crisis. The student should aim to complete all of their hours unless faced with closure of the organization, illness due to COVID-19, or similar. Remote or virtual internships are encouraged where appropriate. The **HTM Internship Coordinator** should be kept apprised of any changes within the workplace, and any questions or issues that arise should be directed their way. (6/30/2020)

If a need arises to seek assistance for a specific concern, students are asked to first contact the internship/field supervisor to discuss directly. If additional assistance is required or mentoring is needed, please contact the **HTM Internship Coordinator** or **Program Director**. (6/30/2020)

My internship/field placement supervisor notified me that the agency is uncertain about or cannot have me working onsite. They offer remote work instead. How should this situation be handled?

We encourage students to take advantage of the virtual/remote working option. The student should notify the **HTM Internship Coordinator** to discuss the [remote] work involved and

to advise if they are transitioning any of their original objectives set, or need to construct new and/or additional goals to meet the revised format. (6/30/2020)

# How will an involuntary termination of my internship/field placement caused by COVID-19 affect my graduation?

Each student will have their situation reviewed on a case-by-case basis; the **HTM Internship Coordinator** will work with the student and a CECI advisor if necessary, to assess the best option moving forward. Alternative employment is encouraged to allow the student to continue with the class. In the event that the student is unable to secure another position, they may have to defer the field experience by a semester and therefore delay their graduation. (6/30/2020)

Remote work is acceptable with criminal justice sites that offer this option. Explore the possibility of fulfilling the internship requirements and engaging with the internship site remotely. Coordinate as appropriate this option with the site supervisor and the **CJ Internship Coordinator**. (6/30/2020)

How will an involuntary termination of my internship/field placement caused by COVID-19 affect my graduation?

Communicate any disruptions and scheduling adjustments with the **CJ Internship Coordinator**. Each internship expectation will be considered on a case-by-case basis due to the unique nature of each internship and each student's learning agreement. The student's remaining internship hours and specifics of the internship agreement will be considered. (6/30/2020)

Traditional policies have been adapted to assist students to meet educational requirements and provide a path to graduation, while maintaining the educational quality of field education. The following provides a brief overview of the requirements for social work field education:

- The student will attend onsite field education when allowed by the organization. When onsite field education is not possible, the student and their field supervisor will develop a plan for remote learning activities and supervision.
- If the organization is not able to provide a sufficient level of onsite field education, or unable to provide sufficient remote learning opportunities, please notify your Faculty Field Liaison and/or MSW Field Education Coordinator.
- The student will follow all organizational policies and processes related to COVID 19; Examples include daily health screenings/temperature, wearing masks, organizational policies for social distancing, etc.
- The field education program and all of its participants will follow all state and local executive orders.
- If a student is immunocompromised, pregnant, or have other health concerns, the student should notify the **MSW Field Education Coordinator** and not attend your field placement site. Consult with your health care provider to fully understand any potential risks present specific to your health condition.
- If a student has concerns related to attending in person field education due to COVID 19, the student should notify the **MSW Field Education Coordinator**.

- In accordance with the Council on Social Work Education, Council on Accreditation, GVSU has change its hours requirement to the following:
  - o Regular status students complete 765 hours of field education
  - o Advanced standing students complete 500 hours of field education
  - o This will remain in place for students graduating by May 31, 2021.
- GVSU is allowing flexibility in how hours are accrued:
  - o The student will work with their Field Supervisor and Faculty Field Liaison to identify a schedule for hours accrual that is educationally sound and allow the student opportunity to develop social work knowledge, skills, and competency.
  - Students are able to complete as many hours per week as their schedule and the site can allow while maintaining the educational integrity of the placement.
  - Once a student has accrued the number of hours required for the semester, an
    evaluation will be completed to demonstrate student competence, and the
    student can progress to the next semester of field education, even if it is prior to
    the beginning of the next semester.
  - Students must enroll in all semesters of field education and seminar, and participate in all seminar sessions and assignments, regardless of when they complete their hours field education. (6/30/2020)

The student should consult with their health care provider to fully understand any potential risks present specific to their health condition.
- If a student has concerns related to attending in person field education due to COVID-19, the student should notify the **BSW Field Education Coordinator.**

- In accordance with the **Council on Social Work Education**, **Council on Accreditation**, the BSW Program has changed its hours requirement to the following:
  - O BSW students complete 340 hours total; 170 hours during the fall and winter semesters.
- The School of Social Work is allowing flexibility in how hours are accrued:
  - o The student will work with their field supervisor and faculty field liaison to identify a schedule for hours accrual that is educationally sound and allow the student opportunity to develop social work knowledge, skills, and competency.
  - Students are able to complete as many hours per week as their schedule and the site can allow while maintaining the educational integrity of the placement.
  - Once a student has accrued the number of hours required for the semester, an
    evaluation will be completed to demonstrate student competence, and the
    student can progress to the next semester of field education, even if it is prior to
    the beginning of the next semester.
  - Students must enroll in all semesters of field education and seminar, and participate in all seminar sessions and assignments, regardless of when they complete their hours field education. (6/30/2020)

BSW students are able to complete required hours remotely as long as there is a mutually agreed upon plan in place between the student, field supervisor, and the student's faculty liaison. Remote learning activities must be meaningful and reflect progress toward the social work competencies. (6/30/2020)

Should a BSW student's field placement be terminated due to COVID-19, the **BSW Field Education Coordinator** will work with the student to find an alternative field placement as quickly as possible.
