- [Regular Faculty Handbook](#) – parts of the BOT policies, plus other policy statements concerning faculty governance, the responsibilities of faculty, evaluation procedures, etc. Many policies are in [the “Shared Governance” collection](#), which are approved by the University Academic Senate and the Provost.
- [Affiliate Faculty Handbook](#) – similar to the Regular Faculty Handbook.
