## **Economics Honors Program**

A few years ago, the Economics Department started offering an **honors program** in conjunction with the GVSU Honors College. Since then, we have focused on providing more advanced academic opportunities to our honors students. Subsequently, starting in the Fall 2018 semester, we will be offering two new honors courses.

• In **fall semesters** honors students can elect to enroll in an **advanced monetary policy course** that is taught in conjunction with the **Federal Reserve Bank of Chicago's Fed Challenge**, which is an intercollegiate monetary policy competition. A team of students will be selected to participate in the Fed Challenge competition in November.

• In winter semesters honors students can elect to enroll in a **project-based course** in which they will work on real-world economic analysis projects with the *Kellogg Company*.

# Alumni Spotlight!



**Phillip Lear**, a 2009 Alumnus of GVSU and a Principal Data Scientist at *Kellogg Company* will be leading the project-based honors course in Winter 2019.

Students enrolled in the course will learn modern data science techniques for analyzing real world sales and marketing questions. Using R and the Tidyverse package, students will learn how to access, explore and understand data to subsequently communicate insights derived from the data using these tools. Once the basic data science framework is covered, students will begin consulting on a current business problem using Kellogg data and presenting their findings to a team from Kellogg.



# **Economics Curriculum Update**

Effective 2019,

- ECO342 Strategic Games and ECO355 Business, Antitrust, and Regulation will be replaced by a new course, ECO355 Markets, Strategy, and Government Policy, which will focus on the application of game theory to the study of market competition, antitrust, and regulation.
- ECO 350 Economics of Gender and ECO 360 Employment, Wages and Productivity will be replaced by a new course, ECO 360 Economics of the Family and Household.
