 - **A.** What does the Office of Sustainability Practices do?: Focuses on lifestyle changes, education, outreach, student engagement

 - i. Motioned by Vice President Fritz and seconded by Vice President Murarescu
 - ii. Motion passes unanimously
 - C. Nominations and voting for EVP
 - i. President Szczepaniak opens floor for further nominations and, seeing none, closes nominations
 - ii. President Szczepaniak reviews election process
 - **iii.** Senator Dowker speaks of her qualifications, citing her previous positions as a senator, what future endeavors she would pursue and her eagerness to begin

- **iv.** Senator Sanchez-Castillo speaks of his qualifications, referencing his perseverance and other leadership positions
- v. Questions for the candidates limit to up to 5 questions each
 - a. Both candidates are asked for clarification on their qualifications, their preparedness for today's speeches, their goals for the future and their relationship with the Senate body
- **vi.** Vice President Murarescu motions to extend questions to up to another 5 for each candidate and is seconded by Vice President Mueller
 - **a.** Motion passes with majority to one (1) nay and one (1) abstention
- **vii.** Additional questions for candidates
 - **a.** Candidates continue answering questions in regards to their goals for the Senate as well as how they intend to achieve them
- viii. President Szczepaniak closes questions
- ix. Discussion: senators may offer their opinion on how to cast a vote
 - **a.** Senators Dorien Thompson, Jenia Thompson, Frappier, and Vice President McMahon offer support for Senator Dowker, citing her preparation for today's speeches, previous experience and her clear goals
 - b. Senator Holcomb offers support for Senator Dowker with a hesitation in regards to how her previous relationship with Cabinet members functioned. Vice President Murarescu clarifies that Senator Dowker has understood the difference between Senate business and Cabinet business
- x. Senator Hicks motions to call to question and is seconded by Vice President Samuels
 - a. Motion passes with a more than 2/3rds vote
- xi. Senators vote using slips of paper
- xii. Two (2) minute break while the votes are counted
- xiii. President Szczepaniak announces the election of Executive Vice President Dowker

 - i. Further nominations
 - **a.** Senator Russo motions to nominate Senator Hicks and is seconded by Senator Sanchez-Castillo. Senator Hicks accepts the nomination
 - ii. Brief discussion (nominated individuals are Senators DeBerry, Hicks and Sanchez-Castillo and Vice Presidents Murarescu and Pagel
 - iii. Voting
 - iv. Votes are counted
 - v. Senate has voted to nominate Vice Presidents Murarescu and Pagel

 - B. Discussion on Resolution F-19-01: SJR E, Whitmer, BoT
 - i. Voting on the resolution will take place on October 3rd after a discussion
 - ii. Discussion on the resolution opens

- iii. Vice President Fritz makes a friendly amendment on wording
- iv. Senator Jacobs makes a friendly amendment to add the word "undemocratic"
- **v.** Vice President McMahon makes a friendly amendment to delete the word "duplicitous", the sentence now reads, "inherently undemocratic and a deterrent to public input."
- **vi.** President Szczepaniak makes a friendly amendment to add the words "State of Michigan"
- **vii.** Senator Hicks calls a point of discussion: Have we worked with other universities in regards to this resolution?
 - **a.** President Szczepaniak has reached out to the presidents at Central, Wayne, Michigan, and Michigan State, to inform them of the resolution and its purpose
 - **b.** Student Conference will take place November 8th and 9th
- **viii.** Senator Houtman comments comments hesitancy on resolution, prefers incremental method
- ix. Vice President Fritz stresses that passing the resolution does not guarantee a positive outcome; references Aboufadel and going to board of trustees with clearer intentions
- **x.** Senator Jenia Thompson expresses concerns about backlash for Senate if senate's name is attached to the resolution
- **xi.** Senator Siegrist comments that passing the resolution may jeopardize relationships with Board of Trustees on behalf of students (and that Senate works for the students)
- **xii.** Vice President Murarescu shows support for resolution, with concerns regarding timeline and process currently being taken (says there does not appear to be too much difference between one in march and current one); references Aboufadel asking that senate comes with succinct request; supports incremental achievements (ex. Finalizing agenda a week prior to meeting, adding public comment to their agenda.)
- **xiii.** Senator Moine doesn't disagree with the goal, rather with the method. Believes the situation could be solved in house and still be an example for other mi schools; in reference to backlash, taking action without knowledge of what backlash could be and how it could affect future bodies
- **xiv.** Vice President Benoit **motions to exhaust speakers list** and is seconded by Vice President Fritz. The motion passes unanimously
- **xv.** Vice President Benoit comments that, regardless of backlash, whatever it may be, this is the purpose of Senate. Benoit supports the resolution; however, if it continues to be shot down, the approach should be changed to incremental
- **xvi.** Vice President Fritz motions to table discussion until its place on agenda next week and is seconded by Vice President Murarescu
 - **a.** Discussion: 5 people left on speakers list, information is available in minutes, senators have left the meeting, discussion is available next week
- **xvii.** Vice President Benoit calls to question and Executive Vice President Dowker seconds
- xviii. Senate votes on the motion to table. Motion passes 23 to 11
