- i. Falls under Hauenstein Center for Presidential Studies. Abby Sachs is the program manager for the Cook Leadership Academy. Emily Mckenna-Makela is the program coordinator for the CLA, she is a GV Alumni and has been at the Hauenstein center for four months.
- ii. Peter C. Cook Leadership academy is a leadership development program that is cross-disciplinary, and co-curricular. Brings you together with students from all majors and fields that are passionate about leadership. They are not tied to any program, they are a supplement to everything you are learning and help you define your own leadership philosophy.
- iii. As student senators, you are all perfect candidates already. They help you achieve your leadership goals with: cohort workshops- to self reflect on your leadership experiences 3 times a semester, public speaking opportunities, wheelhouse talks, individualized mentorship from someone in your field, professional development opportunities, and local partnerships for networking. Offer opportunities to attend and network at many events in the Grand Rapids Community.

Time commitment: Semester overview: 21 hours- 3 self reflection workshops (9 hours), 1 leader lab (3 hours), 3 wheelhouse talks (6 hours), 3 mentor meetings (3 hours) Academic year: 60 hours: 2 semesters- 42 hours, Fall orientation- 12 hours, 1 volunteer opportunity 1-4 hours, networking event- 3 hours. They stream all events on zoom and have makeup opportunities if you have a conflicting class or work.

- vii. Hoogwerf: how many students are accepted?
 - (1) Sachs: 65 students, kept small to engage with everyone.
- viii. Haas: Any interview tips?
 - (1) Sachs: don't be too scared
 - (2) Kidd: be authentic. The point of the interview isn't to come across as this perfectly polished leader but to come as who you are as a person, share the approaches you take that are different, experiences you have had that have shaped you into the person you are today.
 - (3) Al Moutaa: before you come to the interview, know what you are looking to gain from the CLA. That way you can bring your purpose into the interview.
 - (4) Sachs: everyone who gets an interview is someone who has leadership experience and is a high achiever academically, they want a diverse cohort from an experience perspective, so share that.
 - (5) Mckenna-Makela: Really great to talk about leadership as a muscle, something that you are working on building. If you are looking at graduating, you can nominate students that you know.
- ix. Hallead: What majors do you see the most?
 - (1) Sachs: intentionally try to build a diverse group: business, poli-sci, engineering, education are common but it changes from year to year. They currently have over 30 majors represented in 65 students. Open to grad and undergrad students.

 - (1) Majority are undergraduate- 70% and 30% are doctoral level students
- xi. Hahs: can you speak on the opportunities for studying abroad and receiving scholarships?
 - (1) Mckenna-Makela: Funding is given through endowments up to \$2500. Can be given for an exceptional learning opportunity that will help your leadership development. They will help you write your proposal and review the proposal and it is great practice on advocating for yourself. Can be for other opportunities besides studying abroad.

- ii. Sharp-Eizinger: what are bylaws?
 - (1) Schmidt: list of rules that control the internal workings of an organization
- iii. Sharp-Eizinger: they typically include: name and purpose, requirements for membership, officer's titles and responsibilities, how officers are elected, how meetings should be conducted, how often meetings will be held
 - (1) Bylaw: basic organizational structure, how senators are directed and appointed, quorum for general meetings.
 - (2) Policy: committee protocol, code of conduct, decisions the executive committee can make
 - (3) Procedures: severe weather guideline, disciplinary procedures, how meeting minutes are distributed
- iv. Sharp-Eizinger: Impression of current bylaws?
 - (1) Quist: thinks they are very inconsistent and vague
 - (2) Proctor: thinks they are outdated, don't align with the needs of the current body
 - (3) Frappier: real changes have not been made since his freshman year, and a lot has changed in the world since then. They have been working really hard internally to stay in practice with the governing documents this year so they have stumbled on inconsistencies. Looking forward to making sure the next body has less issues.
 - (4) Al Moutaa: it leads to a lot of misinterpretations. They are not clear.
 - (5) DerPilbosian: unnecessary bureaucracy
 - (6) Overheard: sitting on a shelf, gut the entire thing, lengthy, overwhelming, difficult to revise, very important to student senate functions, we owe it to the next senate body
- v. Timeline: now- identify potential amendments, next few weeks- CTF team will review edits, by spring- university legal will review, ²/₃ vote to pass the final bylaws, hopefully will be effective for the next body
 - (1) Kidd: they will go up at the 2nd to last final meeting and then will go up for voting on the final GA, which is also the final consulting session.

 - (1) Hallead: Article I.02-the way they did election this year is working, changing to 25 members of the student body and 1 faculty member. Take out the last sentence. Article II.04- wondering what the purpose of a write in is?

- vii. Everly: main thing they came across was unnecessary repetition, article III-comments on verbage things, main change was section 3.02 and 3.03- both list the same parties that you have to go through, so it could be condensed to not confuse people. Nothing to say about article IV.
 - (1) Kidd: office operations, unless just the structure, would be moved into policies and procedures
 - (2) Schmidt: change the article name to executive office
- viii. Hahs: Article X- condense a few things- section X.02- combine b and c, does not think h is necessary. Article XI.02.d- change to maintain liaisons to make consistent, make sure it is a colon instead of a comma at the end. E can be struck
 - (1) Kidd: d could be reworked, each year it is going to be different
 - (2) Frappier: some of these things that are in the committee descriptions should be things that all of the student senate should be addressing.
- ix. Flickinger: Article IX- looks good, X- thinks g and h are the same thing, Bucon said that it is tough to get Allendale and Pew campuses together which is why there are different subsections. These articles regarding each committee talk about the purpose and responsibilities, those are not bylaws, all that is covered in the SRC document, so they might need to flip flop them.
 - (1) Frappier: correct
 - (2) Mandy: what authority each committee has should be noted in the bylaws
- x. Kidd: echoes Flickinger's thoughts, multiple contradictions in conduct and impeachment systems but also multiple pages on procedures, which do not belong here.
 - (1) Biermacher: echoes for subcommittees
 - (2) Mandy: Bylaws are often used as a catchall which is not helpful, bylaws should be used to guide your operations and they are trying to be everything to everyone and that is not helping anyone.
- xi. Bucon: Article VIII.03- this year they liked having inservice in both semesters but right now it is only optional for the winter semester. Thinks it would be smart to have it in both semesters.
