III. Guest Speaker: Doug Wentworth, Auxiliary Services

- a. Thanks everyone for the time and effort they put into campus, he really appreciates it.
- b. What are auxiliary services? A department that provides service to the GVSU community- campus dining, copy centers, conference and event planning, laker stores, meadows, and vending
- c. It is different from other departments because auxiliaries are all funded through the revenues generated at each operation. Fully self supportive operations- no tuition or state funding goes into it. Revenues are used to pay all expenses and enhance services provided. Covers all utilities, salaries, construction, and any other expenses. They get university discounts but they still pay for everything.
- d. He has 5 direct reports, but cannot be done without a large group of people, including over 1000 students. Beth Junglas does downtown laker store, Tony Glaub does Allendale laker store, Paul Kramer oversees all dining facilities, Don Underwood is director of Golf Meadows, and David VanderShoot is director of conference and event planning.

e. Laker food company

- i. provides dining to all students and the larger GVSU community including residential-Fresh Food and Dish, retail- all other dining options such as Bento, Panda, Subway, C-stores, and catering services on both campuses.
- ii. Offers a variety of meal plans for residential and commuter students- unlimited meal plans, weekly meal plans, semester plans, and dining dollars.
- iii. Meal exchanges allow you to use meals at almost all locations except starbucks and Bento but dining dollars still work there.
- iv. Support student success with internships, scholarships- aramark supports 2 fully endowed scholarships at GV every year, donations- food and beverage donations to student organizations, including GAs, and meal share programs.

- v. Contracted partnership with Aramark. Get a lot of efficiencies and access to their expertise- buying power, data, and staffing, which allows them to save money and offer a better price to students. GVSU still controls what offerings are here and what the cost is. Aramark provides food and staff and GV provides equipment and facilities. If you see a brand such as Starbucks, it is a franchise owned and operated by the university and contracted through aramark.
- vi. Does the Laker Food Co. currently have an ongoing sustainable meal donation program like other universities utilize? He has researched a lot of other universities. They have the Laker meal share program-students can donate their meals to a bank during two windows in the year and then they are handed out at replenish to students who need a meal. Implemented 5 or 6 years ago, vending contracts donate \$50,000 each year to financial aid and students can request dollars to be used for food through the office of financial aid. They do it through the financial aid office so they can keep track of all that and make sure no student is penalized for going over their limits.
- vii. Does laker food company have any plans to recreate or renew contracts with food places such as which-which and Qdoba? They haven't ended their contract with Qdoba, they could reopen it if they wanted but they really needed to open an allergen friendly option because the need has increased for allergen free dining. It is not totally allergen free because it is not closed off with glass so they have to say it is allergen friendly. They reopened Zoca downstairs in Kirkhof, and that is almost identical to Qdoba, they use shredded instead of cubed meat but other than that it is identical. As they continue to look at stuff they will see if the need for Qdoba is still there. Which-Which was closed because people wanted a different kind of food and wanted to see sushi. They had a lot of sandwich options and that was their slowest sandwich place and slowest location. Bento has done really well. But it still could come back. Lower level commons is down because the dining program was built when they had over 6,000 students living on campus and over 25,000 students enrolled and those numbers are significantly lower now. If those numbers change then they will look at opening things back up. They're not dead, they still have access to them.
- viii. Is there any chance for an expansion of fresh food company hours? They moved a lot of freshmen from north campus to south campus and they didn't have the volume there that they did before. They are looking at that and the hours are being evaluated for next year. It is definitely a future possibility, but right now the volume is not there to expand the hours.
- ix. Any plans to reopen fusion for dining? Monitoring things such as- where students are living, how many students live on campus, and where students are eating. If they had numbers higher than what they got this year they had plans to reopen it but the numbers are too low.

- x. What allergen friendly dining options are on campus? True balance at Dish, coolers at Fresh, if you go to any location on campus and have a specific allergy they can make it allergen free or get you something very comparable to what you want. Ask for a chef at any location and they can do that for you. Some brands limit what you can do like they can take things out but can't introduce new items because they are locked into brand standards. But a chef will work with you to accommodate your needs.
- xi. Biermacher: Thanks to him for joining us. Since they are funded by an auxiliary budget, what strategies do you use to project costs for the year?
 - (1) With 15 years of history, and the consumer price index they can see trends. Know exactly how many full and part time staff members they will need based on the current model. Much easier to project before COVID. Overall revenue is between 19-20 million, but it is so different now, a lot of remote classes. Getting better at projecting post-covid every year. Get numbers from institutional marketing and get projections. They buy all of their stuff locally so they can tell them prices and increases and decreases. They use all the trends and it is a complex process
- xii. Flickinger: mentioned Jets contract, it is awesome. Are there future plans to get other fast food places on Lake Michigan contracts to help with dining dollar spending and event options?
 - (1) It is complicated because it is based on volume. Some of the money stays in the university, but if they contract everything out then no money comes back because there is a cost to maintain it. So they have talked to other people and they do not want to agree to the terms. Downtown probably has a better option to do that but in Allendale they feel like they will get your business anyway so they don't have many options.
- xiii. Kidd: if you have any more questions for Doug she meets with him regularly so she can get your answer to you. Thanks him for coming and for everything he does for them.

- a. The Executive Vice President for Student Senate must have fulfilled one (1) elected term on the General Assembly prior to their election to the position of Executive Vice President.
 - i. An elected term is defined as one (1) year beginning with the General Elections held the previous academic year.

Section III.04 President

a. The President for Student Senate must have completed fifteen (15) academic weeks as a member of the Student Senate General Assembly prior to their election to the position of President.

Section III.05 Executive Vice President

a. The Executive Vice President for Student Senate must have completed fifteen

- (15) academic weeks as a member of the Student Senate General Assembly prior to their election to the position of Executive Vice President.
- (3) Rationale: the current governing documents do not reflect the current needs of a post-covid world. Based on what he has heard there are 4 people that can run for these two positions that meet these requirements and he and Bates as two of those people will not be running for these positions. Thinks this needs to be changed so they can function smoothly and serve the body.
- iv. Schmidt: as chairperson of the elections commission, the elections commission has no opinion on this and is staying neutral. As this is an official amendment and will impact future bodies, elections commission members will be voting. His personal opinion, he is very much opposed. Thinks they should only do it for the EVP if they do it all. In order to be president he thinks you do need at least 2 years of experience. Does not think you can understand how the student senate works with only one semester of experience.
- v. Hoogwerf: echoes the same sentiments of VP Schmidt. Presents have to have a lot of connections within the university. If someone only serves on the body for 15 weeks and then is thrown into this position she thinks it would be really difficult for them. For EVP, she thinks they can change it.
- vi. Proctor: unfortunately none of the 4 eligible people have 2 years of experience. Given a hypothetical situation next year they have 2 people running for president- one was elected in september and is a general senator for a year and the other is elected a few weeks later and is elected to a VP position and is very involved. Who is to say senator B couldn't handle one of these roles. They have a young cabinet, Everly, Bucon, and Haas were appointed members that have not been on the body for the required time and have plenty of connections.
- vii. Schmidt: hears Proctor and thinks rules yield unfortunate standards and standards will always affect people. Have to think of somebody who is most likely to have best experience. That is just a hypothetical and it is an unfortunate situation. But on the basis of logical reasoning they have to think which situation will yield the most desirable result.
- viii. Bucon: appreciates all your work and all those involved in CTF. This is her personal opinion. She echoes opinions that have been said, sees both sides. Thinks it is something they can look at and think more about. Would support this with caution but does see the need.
- ix. Proctor: 15 academic weeks comes from one semester, 4 eligible people currently and under amendment it would be 10 eligible candidates. Last year there were 23 people that were elected to the body. Despite best efforts to restructure, they have 21 candidates running for next year. Given that trend it is not hard to imagine that next

- year they will be in a very similar situation as this year. This amendment is going to allow the future bodies to make the best decisions to best help their body.
- x. Frappier: he ran super heavily on experience in the past 2-3 years. When he lost his first EVP election the person he lost to should not have even been elected per this section but he killed it and did a great job. He has the most experience on the body but that does not put him on a pedestal. He has more experience than Kidd but he could not do her job.
- xi. Hahs: he is in full support of this change. If you are not in favor, please see both sides. Experience will always be an argument but for the need of the upcoming body engagement and accessibility is what is needed to give the body the tools to make the best decision.
- xii. Schmidt: in support of amending section III.05- EVP requires less knowledge of inner-workings of the entire bureaucracy. Thinks someone can come fresh off of an election. President has to learn the inner workings of the entire university. Not saying experience is the only quality but spending time making these decisions is very important. Need to think of future bodies, not only next year's body. Not just thinking about next year but 3-10 years down the line
- xiii. Flickinger: worries that it will leave them very vulnerable. Heard a rough estimate that half of the 21 will be brand new and will be voting for VP spots without knowing any of them. It is very hard to show experience on first impressions. Someone who was on the body for 15 weeks, doesn't know what they are doing but is really great at talking so they get elected and the senate collapses due to their lack of knowledge and experience. If they grow down the line it can bring them back down.
- xiv.Kidd: the point of this discussion is to bring new perspectives and avoid circular reasoning.
- xv. Haas: In future CTFs 5-10 years down the line do they have the opportunity to make amendments?
 - (1) Frappier: the assembly has to vote on constitutional amendments. This is coming from Proctor as an individual, not CTF. But yes, any amendments can be made in the future with a vote.
 - (2) Haas: thinks they are not the only organization that has to restructure post-covid
- xvi. Hallead: think about the VP who has made so many connections and events who was on the body for one week before becoming VP. Does not make her any less qualified for a position she is in now.
- xvii. Roubos: thinks changing the wording to include if the body was below a certain number of people could be helpful
 - (1) Kidd: suggests meeting with Proctor, really appreciates that perspective

- xviii. Proctor: addressing Flickinger, reminds everyone that during the VP elections last year they had a very close race and new senators were voting to decide. If you look at the meeting minutes it shows senators who knew both of them informing new senators on who they think would be the best fit for the position.
- xix. Schmidt: addressing the comments about the lack of experience, serving in their role showed everyone how qualified they were. If you didn't have any time to be on the body you wouldn't have any time to showcase your ability.
- xx. Everly: talking about III.05- the EVP and her work very closely and she couldn't imagine not having an EVP. Of the four eligible candidates she hasn't heard of any of them wanting to run for EVP. It is so important and crucial to the success of the senate to have an EVP.
- xxi. Kidd: has a pretty good grasp on the role of the president. All schools in Michigan are dealing with low engagement. See new faces voting in elections every year. That is the beauty of democracy. She sends emails which she learned from taking college courses, sits in meetings with people that she met when she took her role at the enrichment dinner, chair meetings and writing agendas which she learned from her transitions report. Learned Robert's rules from Schmidt who has less experience than her. She does a lot of public speaking that she learned through community college. The president needs to be organized and communicate. They are set up for success and have an amazing advising team that helps them with everything. An additional 15 weeks would not have mattered. She is the least qualified in experience out of the president's in the past 5 years, previous presidents have resigned, ran illegitimate elections, and brought lawsuits against the university. Her VP with least experience in the cabinet has been doing great.
- xxii. Schmidt: do you think a sophomore could do your job?
 - (1) Kidd: yes. She would give her position to Haas or Everly and have total trust in them.
- xxiii. Proctor: when you are younger you are going to have more time to put into your role. Schmidt says it is a huge time commitment and juniors and seniors do not always have the time it takes. Barely figured out this was an issue in time so he foresees this being an issue in the future too.
- xxiv. Schmidt: thanks everyone for their perspective. Understands he gets passionate but he is not mad at anyone, thinks everyone is wonderful. Just coming from a palace of passion.
