Re: Student Fellowship and Faculty Grant Opportunities through MSGC (2023-2024 Cycle) in

Arts, Science, Technology, Engineering, Mathematics, Aerospace, Space and Earth Science.

Grand Valley State University is an affiliate member of NASA's Michigan Space Grant Consortium (MSGC), and a participant in fellowship and grant funding opportunities competitively offered through the consortium. The deadline for MSGC proposals is Wednesday, November 16, 2022.

All applications are on-line at https://www.mispacegrant.org/ for 3 major categories of fellowships/grants:

- 1. **Fellowships** for undergraduate and graduate students who will conduct research mentored by GVSU faculty.
- 2. Research Seed Grants for staff and faculty members to initiate new lines of scholarly activities.
- 3. **Program grants** to support pre-college education, public outreach and teacher training.

Your chances of success are maximized when you match your project with the <u>Vision and Mission of MSGC (http://mi.spacegrant.org/index.php?page=about-us)</u> and the <u>Strategic Goals of NASA 2014 and 2018 (https://www.nasa.gov/sites/default/files/files/FY2014 NASA SP 508c.pdf; https://www.nasa.gov/sites/default/files/atoms/files/nasa 2018 strategic plan.pdf).</u>

I am available to discuss ideas and issues concerning submission of a proposal, and can guide you to other sources of help at GVSU such as mentor-student relations for fellowship applications, securing match for seed and program awards, and finally routing of proposals through GVSU's Office of Sponsored Programs (OSP).

 Please get back to me by September 30, 2022 with your intention to apply. Proposals must route on Streamlyne/Cayuse for internal GVSU approval by October 29th, and be complete, approved and ready to submit by November 9th. Deadline for applications is Wednesday November 16t^h, 2022.

Tips for Successful Proposal Preparation to Meet Deadlines and Award Timelines:

- Contact me early with your intent to prepare and submit a proposal (by September 30).
- Run a draft/outline of proposal by me at least 3-4 weeks prior to the deadline (by October 21).
- Students work with faculty mentor to finalize a project proposal that mentors route via GVSU's Office of Sponsored Programs OSP (by October 31).
- Faculty/Staff write proposal, obtain match support letters from Department/Dean, and initiate proposal approval routing through the OSP on Streamlyne/Cayuse (by October 31).
- All proposals are complete, approved and ready to submit (by November 9).
- Students submit fellowship applications and Faculty/Staff submit Seed and Program grant applications online directly to MSGC following approval by OSP and me.
- MSGC proposal online submission deadline is Wednesday, November 16, 2022.
- Award notification: February end 2023; Fellowship/Grant period: May 2023-April 2024.

Note: Only US citizens may apply for the MSGC fellowships; non-citizen faculty and staff may apply for seed/program grants but may not claim salaries, stipends or travel expenses.

<u>I.</u> <u>Undergraduate and Graduate Fellowships:</u> (including the Undergraduate - Underrepresented Minority Fellowship Program).

Fellowship awards for undergraduate and graduate students are \$4,000 and \$5,000, respectively. Students will be paid a stipend during a ten-week summer period – but these funds may be spent throughout the 1-year grant period. Each fellowship student must work closely with a faculty mentor. **Note:** Students must be US citizens to receive the fellowship. Faculty must route their student's proposals through GVSU's internal routing process on Streamlyne for approval before submission.

II. Research Seed Grants: Funding to support junior faculty or research scientists up to \$5000 with a 1:1 cash match. Non-federal matching contributions can come from start-up, professional development funds, department contributions, and the dean's office. Application must include an official institutional letter confirming the cash match. Funding can be used for salary, travel and to purchase supplies and services. Funding cannot be used to purchase equipment or to pay salaries or stipends of faculty or students, or travel of persons who are not US citizens. Note: New faculty members are particularly encouraged to apply. Past Seed Grant recipients must wait 1 year before reapplying.

- III. Educational Program Grants: The following funding opportunities also require a 1:1 cost match (cash contributions or in-kind support) with non-federal funds. Application must include an institutional letter confirming the non-federal match. Maximum award in each category is \$5,000 but additional "Augmentation" support is available (see below). Applicants can propose individual projects to any of the three programs (Pre-College Education, Public Outreach, or Teacher Training) or can propose one project to multiple programs simultaneously, depending on the scope and relevance of their project. A detailed budget describing how the funds will be used is required. Note: Applicants currently funded through these programs may reapply for continuation of funding but will be required to submit a progress report for evaluation.
 - a. *Pre-College Education Program:* Promotes projects that encourage and enrich the study of mathematics, science, and technology for K -12 students.
 - b. *Public Outreach Program:* **S**upport conferences, workshops, publications, lecture series, non-technical courses, science fairs, radio and TV programs and other enrichment events that serve the community and enhance science, mathematics, and technology literacy and interest.
 - c. *Teacher Training Program:* Designed to promote innovative higher education of pre-service and in-service teacher training in science, mathematics, and technology.
 - **d.** Augmentation Support: Additional support is available for Pre-College Education, Public Outreach, and Teacher Training proposals targeted toward the recruitment and retention of women, underrepresented minorities, and persons with disabilities. Augmentation funding is limited to one proposal per applicant.

Award Notification, Grant Period and Additional Resources for Applicants:

Award recipients will be notified of their selection by February-end, 2022. Funds will be disbursed in early May 2022, pending receipt of the budgeted federal funds. The funding interval for the fellowship/grant is from May 2023 - April 2024. A brief interim (half-year) and final project reports will be required.
