

Public Administration Program Podcast

Hello, my name is Kelsey and I am a staff member in The Graduate School at Grand Valley State University. Thank you for taking the time to learn more about the Master of Public Administration program at GVSU. Today we're going to cover the admissions process, program requirements, and the qualities that distinguish this program.

Let's start by explaining to you what this program entails. The Masters of Public Administration will prepare students to become local government managers, public policy analysts, administrators in various health care settings, or in nonprofit organizations through lecture and lab courses. This is a 39 credit hour program or 42 credit hour program for pre-service students admitted without 3-5 years of professional experience. The program can be completed in two and half years as a full-time student or approximately 4 years as a part-time student.

Demand for Public Administration graduates is growing. In fact, according to the Bureau of Labor Statistics, there were more than 6 job openings in public administration for every Public Administration graduate in 2012. Public administrators are needed in all levels of government as public sector consultants or even in the private sector working on important public issues.

Standard GVSU admission requirements include completion of the online application as well as a Bachelor's degree from an accredited institution of higher education. Your application must include official transcripts, and if English is not your native language you must provide scores from one of our approved standardized tests such as the TOEFL, IELTS, MELAB, or the PTE Academic. There is a \$30 nonrefundable application fee, however this fee is waived if you attended GVSU previously or are currently attending GVSU.

Additional requirements for application to the Masters of Public Administration graduate program include a current resume, three letters of reference from informed sources, and an essay outlining career and educational objectives while in this program.

The great news about GVSU's graduate programs is that tuition rates for Michigan resident and non-resident students are the same. In other words, there are no extra costs for being an out of state student. The Masters of Public Administration program at Grand Valley is a 39 credit hour program or a 42 credit hour program for pre-service students. 18 credit hours comprise the core curriculum. These classes review the foundations of public service, research methods in public administration, human resources, organization theory, and public finance. An additional 15 credit hours are dedicated to one of our concentration areas: State, Regional, and Local governance; Policy Analysis, Advocacy and Evaluation; Health Administration; Nonprofit Management and Leadership; and Criminal Justice Administration. 6 credit hours are counted towards electives which can be drawn from courses in another concentration area, from workshops, or from complementary courses taken

outside of the School of Public, Nonprofit and Health Administration. Workshops are 1 credit hour intensive courses that focus on issues of interest to public, nonprofit and/or health administrators. Students can take up to three of these 1 credit hour courses to be counted towards the six elective credits that are needed for the Public Administration degree. Students with less than 3-5 years of experience in a public, nonprofit or healthcare setting will be required to complete a 3 credit hour internship prior to graduation. This program has been accredited by the Network of Schools of Public Affairs and Administration since 1994. Students in our program benefit from small class sizes, and instruction that incorporates the teaching of both practical and theoretical perspectives on issues facing public administrators today. The Masters of Public Administration program helps students develop skills and techniques used by leaders and managers to implement policies, projects, and programs in public-serving organizations. If you are strongly motivated to be an effective, ethical and innovative organizational leader working for the betterment of your community, this program is your best choice.
