Product substitutions of equal or greater value may be made at the discretion of Grand Valley State University.

Grand Valley State University is a cashless campus. If selecting a cash bar, all payments must be made with a debit or credit card by event guests. Cash will not be accepted under any circumstances. Please communicate this to your event guests if applicable.

Per University policy, we do not serve shots or liquor poured neat or on the rocks. All liquor must be served with a mixer.

A bartender fee of \$85 per bartender will be assessed.

Food and beverage services are subject to a 6% Michigan state sales tax and a 20% service charge.
