Grievance Arbiration:

Per Diem and Fees: \$750 per 6 hour hearing day; writing, research, preparation pro-rated at per diem rate.

Interest Arbitration and Fact Finding: Applicable rate established by MERC.

Cancellation:

\$500 within 48 hours of hearing;

\$250 if notice is received between/after 48 up to 120 hours; \$750 plus expenses if cancelled at hearing.

Postponement or adjournment: \$150 between/after 48-120 hours; \$500 if less than 48 hours.
