Research Interests

My main research focus is the psychology of religion and secularity. I have studied patterns of mental well-being and prosociality as a function of religiosity as opposed to secularity. I focus on identifying and distinguishing dispositional influences on prosociality and well-being (personality, moral character) from situational influences (group participation, social support). Several of my other projects have investigated religiosity and fundamentalism using the social cognition concepts of Just World Belief and Terror Management Theory. I have also published research on alcohol and drug use and abuse.
