Re: Sabbatical Eligibility for 25-26, Preparation, and Overview of Timeline (link to this memo)

Date: 23 April 2024

The purpose of this memo is to share information regarding sabbatical eligibility, preparation, and the overall timeline for the review of sabbatical proposals for the 25-26 academic year. The process this year will be similar to the process last year.

Eligible Faculty¹: There are 11 faculty eligible to apply for a sabbatical for the 25-26 AY: Rene Ardila, Matt Boelkins, Will Dickinson, Brian Drake, Hope Gerson, Salim Haidar, Jon Hasenbank, Firas Hindeleh, Shelly Smith, Robert Talbert, and Akalu Tefera.

Communication with Unit Head: Please let Esther know by June 7 (or sooner) whether or not you plan to apply for a sabbatical. Sabbatical applications are due by 9/1. It's fine if your answer is tentative - this information will help the leadership team (tentatively) plan the schedule/review process.

Feedback: We encourage you to solicit feedback on your sabbatical proposal from colleagues both within and outside the department before the submission date of 9/1. By the time your proposal comes to the department, it should not need substantial revisions in order to be approved. Please take advantage of opportunities to receive feedback throughout the summer. In particular:

- If you need help formulating your proposal or even simply brainstorming ideas, several of your colleagues are willing to help! Just email me (billinge@gvsu.edu) with your request and I will connect you with an appropriate colleague.
- University Sabbatical Review Committee members are willing to pre-read and provide feedback on sabbatical proposals. You must submit your draft by July 1. Details about the pre-read consultation will be shared at the meetings. It is anticipated that colleagues can

request pre-reads using a web form (as was done last year). The form isn't open at the moment but should be available soon. Alternatively, you should be able to email your proposal to csce@gvsu.edu and the office will pass on your proposal for the pre-read and feedback.

Submission Deadline: All applications for sabbatical leave must be submitted through the <u>electronic system</u> (MyApps) via the sabbatical website by the <u>university deadline</u> of **11:59 p.m., September 1**.

9/1 - 9/30/24 Tentative review schedule 9/1-9/18/24 9/23/24 (8am revised proposals due)	Departmental Review *Advisory Committee (AC) reads proposals, meets with proposer and provides feedback; Department members read proposals and have the opportunity to provide feedback; Proposer incorporates feedback from department and revised proposal available for departmental members to review. If revisions are requested, the revised proposal must be submitted by the applicant to the sabbatical website, and the call for votes will be made after reviewing the revised proposal.
9/25/24 Department Meeting 9/30/24 (unit recommendations due)	Department meeting to discuss proposals and offer feedback identifying strengths and weaknesses of each proposal that will be used to create a rationale of support. The call for votes will be made after reviewing the revised proposal. TT faculty vote on each proposal: recommend, recommend with reservations, do not recommend. Votes of "recommend with reservation" or "do not recommend" should be accompanied with a rationale; final revised proposals uploaded into system and unit head reports vote and department rationale that includes, justification for unit's recommendation, listing of proposal's strengths/weaknesses from discipline perspective, vote results, and verification that request amendments were completed.

1/31/25	Final decision from Provost
