 - Microcredential Proposals Create a proposal form and process for review and approval of microcredentials in partnership with UCC (SHORE Log: 1187-2020)

New Business

- UCC approved the OEMC badge proposal forms in SAIL:
 - UCC sent a memo to approve the second microcredential form (now to be called the Badge form 2) and the check box for the course change form (check box is for "change badge"), and the first microcredential form (also to be called the Badge form 1) has already been approved. Discussion regarding when these will be made available via SAIL ensued, and we decided that sooner is better.
 - Update links/verbiage on UCC and OEMC website (take down CMS websites); Krystal has been cued that this will be happening soon.
- Hyflex/Dual Delivery definitions revisit conversation from earlier this semester (this was put on hold on 9/29/21); see 9/8 agenda for more context/information
 - Those courses requested for hyflex, currently at GVSU, have to at least be

- approved for hybrid.
- It was suggested that hyflex is a different skill set than either hybrid or online.....Need to continue discussion/conversation.
- We are but one group that is discussing this definition/type of learning.
- The OEMC can make a recommendation, however there are implications for many other new/change course proposal processes and approval categories
- Microcredential Pilot Process Review
