b. Vandana Pednekar-Magal presented background information on the School of Communications restructuring efforts and identified concerns the faculty in the School of Communications have with the process.

Dean Fred Antczak stated that he and Provost Davis made an administrative judgment regarding the restructuring of the School of Communication.

Discussion was heard regarding the process and on the Executive Committee of the Senate statement that was distributed earlier, which reads:

"The Executive Committee of the Senate (ECS) believes that the 2016-17 restructuring of School of Communications was not conducted in a manner consistent with the principles of shared governance. Shared governance relies on transparency and mutual accountability.

We believe that the process of this reorganization was inconsistent with the implications of section 2.01.A.1.a.ii of the Faculty Handbook. Furthermore, the Unit Head selection processes stated in section 1.04.B of the Faculty Handbook were not
