Report from the Chair: UCC Chair has been asked to attend the full UAS meeting this week.

New Business

Discussion of results of the HERI survey Comments: It was noted that we should see a trend over time (multiple data points are needed) prior to any concern on a 'trend' that would call us to action.

Action: Continue discussion when more data is present or explanation of the significance noted.

Discussion of UCC's instructions on filling out an SOR

Action: Currently, no action is to be taken. UCC Chair will solicit suggestions from the other College Curriculum Committees. Possible changes: (1) a 14 week schedule may be useful to mandate, but no motion was taken. (2) strike the words "in weeks" and add "proportion of time spent on". (3) Last sentence could be reworded as following: "course content should reflect a full semester's worth of content to be covered in the discipline".

#7326 Writing Major PCR

Action: PCR tabled until after discussion with WRT Chair

Comments: (1) Plan of study document describing modules that can be taken, needs to be changed to: "from any of the 3 modules, take 2 courses from each module" to something like "complete 6 courses, 2 courses from 3 modules". (2) Concern about software resources for the new classes. (3) Overlap with WRT 350 (business communications), as well as courses in other programs including graphic arts, and journalism.. (4) Should the program also contain reading of the great works of literature in order to support modeling of writing and foster critical thinking? (5) Communication from English is not an endorsement of the proposal. Has this concern been addressed, and will there be a negative impact on English majors? (6) Some courses have a limit of 18, others 22. Why the difference and is this going to cause some areas to have too many students? (7) Catalog copy uses 'academic writing program' to refer to writing in the General Education program. This could be confusing to students. Perhaps rename to "General Education Writing Requirements".

(2) There seems to be significant content overlap between WRT460 and WRT 465. Please address the extent of the overlap between these courses and the distinction between the two courses. It seems the courses have different prerequisites but are covering the same thing.

Amendments: (1) Difference between advanced magazine writing and advanced non-fiction writing is not clear. Try to distinguish writing and journalism. (2) What is meant by "broad and open form careers"? (3) There appears to be significant overlap between journalism and this course. Please address what makes this course unique and warranted.
