- a) examine course repeat policy-how is it progressing? Should changes be made? Seats are being taken in certain courses that are trying to raise GPS from a B to an A. - b) Oversight of online course management proposal system. Prospecti and new program proposals need particular attention these are new workflows in the system.
- c) Work with the Grad council to consider a University level GCC. Consideration of a dual system for both graduate and undergraduate review.
- d) Integrated BS/MS programs: how can the transitions be smoothed out-revisiting of a 3+2 program?
- e) Finish the BS/BA cognate charge-some responses from Units were not useful. Develop questions for Units that will be more useful.
