Report from the Provost:

- a) Ellen reports a single typo change in a course description (remove an “ing”). In consultation with UCC Chair, the editorial change was approved.
- b) Ellen sent a course that we had already approved back to Honors to realign with their current curricular revision, they will do so.
- c) Several 4-credit X99 independent study options (in modern languages) were approved, which is different than the UCC policy of offering independent study courses only at 1-3 credits. UCC accepted this exemption.
- d) Last semester the UCC approved a curriculum map requirement for NPP’s, optional for PCR’s. The Website (with this information and an exemplar example from Nursing) is now available and SAIL is being modified to include this. Becomes required as soon as the link is live, and as NPP’s leave the department the curriculum maps will simply be appended to the proposals. Next Noteworthy will include this information.
- e) KCON- requested a moratorium on admissions for MSN students. There are currently only 5 students, who will continue and be provided for. This means that KCON gets a year to make alterations and return it as a vibrant program. UCC members approved the moratorium.
