- 1) Ellen S. reported that an enrollment census will be on the institutional analysis website tomorrow.
- 2) Program review will be occurring this semester, for a "quick health checks on programs", and Lindsay C. and Sue E. will be serving on related subcommittees. There will be varied data provided to programs (data dashboard) and units in relationship to university planning.
 - 3) Ellen reported info on a request from the Brooks College of Interdisciplinary Studies (COIS) concerning the INT prefix (which currently does not belong to any unit). The Honors College has offered to take it, to allow unit oversight over the INT prefix. Ellen S. would get UCC support to approve this change, which would then need to change the SAIL routing for INT courses.

Motion was made and seconded to support this request from the Provost's office to move the INT prefix to under the Honors College, and perform SAIL actions. Motion passed unanimously.

4) The COE no longer has to report ACT/SAT scores of teacher candidates per their accreditation agency, CATE. They would like to delete the catalog language for admissions for undergraduate and graduate levels. Graduate program has already been ok'd to drop this admissions language. As there is no place for this to occur in SAIL, Ellen S. is bringing the issue to LICC.
