 - **1. University-wide Accepted Nomenclature for Majors:** Work with the records office to determine what nomenclature is used (concentration vs emphasis) and consider if all units and colleges can use a single nomenclature.
 - **2. Avoiding Duplication of Credentials:** In collaboration with OEMC, examine micro-credentials, specifically certificates (UCC) and badges (OEMC), to ensure that there are distinguishable differences between badges, certificates, and minors (to avoid duplication of credentials)

OEMC also has this charge – suggestion to let OEMC take a first attempt and will update UCC as needed.
