- Sea sponges.
- Menstruation huts.
- Wood pulp pads.
- Garter belts.

### A BRIEF HISTORY OF HYSTERIA

#### Pre-1900s


- Periods and women as unsanitary, unhealthy, and unstable.
- Greek "restless uterus" and the "Female Nature."
- 1831: Menstruation is detoxification for women.
- "Every woman carries with her the seeds of hysteria."

#### 1900-2000s

- The Rest Cure.
- Stereotypes regarding pre-menstrual syndrome and hormonal "rages."
- 1970s: embracing menstruation is the first step to feminism.
- Social media activism.





# INTERNAL ANATOMY

- Vagina tube-shaped organ, approximately 3-4 inches long when unaroused.
- In resting state, vaginal walls touch. When aroused, they balloon out to allow penetration.






Uterus after hysterectomy


# **EXTERNAL ANATOMY**


- External genitals sometimes referred to as the vulva.
  - Clitoris
    - Glans, bulb, & crus
    - Prepuce
  - Mons pubis
  - Labia minora Inner labia (lips)
  - Labia majora Outer labia (lips)
  - Vaginal entrance
  - Urethral opening

# What Is Derival Doverty?

Period poverty is when someone is not able to access or afford period products, like pads and tampons. When people don't have access to running water or toilets, the effects of period poverty can get worse.

#### Living in period poverty may mean:



Missing school, work, or job interviews



Suffering from high levels of anxiety and depression



Running away from homes/placements



Having to choose between buying groceries or paying bills and buying period products



Using unhealthy alternatives to period products



Health problems such as UTIs and bacterial vaginosis from using alternative products

# PERIOD POVERTY: WOMEN'S PRISONS

- Products given are scarce and cheaply made
  - 5 pads/week/cell
- Commissary is not accessible to every individual
- Periods as humiliation

## PERIOD POVERTY: TRANS AND GNC INDIVIDUALS

- Increased dysphoria surrounding menstrual products
- Lack of products in men's restrooms
- Financial inaccessibility

- Traditional menstrual products (pads, tampons, or tampons with applicators) are the most used among those who experience periods- meaning they have the largest impact
  - We might be quick to point to physical waste, but the largest environmental impact comes from the raw production of these products

# SO WHY DO WE USE THESE PRODUCTS SO MUCH?

- Ease of access
- Advertising power
- Information about how to use products
- Narratives surrounding menstruation
- Alternatives are pricey (?)

# WHAT IS MENSTRUAL EQUITY?

In order to have a fully equitable society, we must have laws and policies that take into account the reality that half the population menstruates. Menstrual products should be tax-exempt. They should be affordable and available for all, safe for our bodies and the planet. Periods should not hold anyone back, period.

# WHAT DOES MENSTRUAL EQUITY LOOK LIKE?

- Comprehensive education and information on periods and period products.
- Removing sales taxes on menstrual products.
- Oversight from the Food and Drug Administration on what is used to make menstrual products.
- Access to low-cost, quality menstrual products.
- Available period products for vulnerable populations, such as homeless, incarcerated and trans individuals.
- Appropriate medical and personal leave for individuals suffering from period symptoms.

# MENSTRUAL EQUITY FOR ALL ACT OF 2021

- U.S. Rep. Grace Meng (D-NY) in May 2021
- "Period products are necessary and essential items for anyone who menstruates, and access to these items are a health care and human right," said Meng.
- A 2019 study found that among low-income women in a major U.S. city, nearly half had to choose between buying food and spending money on menstrual products.
- The recent State of The Period 2021 study shows that nearly 1 in 4 teens in the United States struggle to access period products. Over 80% of teens say they missed school or know someone else who has.
