- C. CCPS Bylaws Approved changes of August, 2012 never incorporated

- E. Issues raised by Mark Hoffman re: newly formed strategic planning task force The issues raised by Mark Hoffman were reviewed and discussed. Concluded was that the CCPS Dean has the authority to form a task force. However, the dean does not have the authority to form a new CCPS committee without a referendum first being held, according to CCPS Bylaws. The assessment task force is not a committee;

therefore, the dean had the authority to form this group. Should the dean wish to make the task force a permanent committee, then the referendum process (as put forth in the CCPS Bylaws) would need to be followed.

Via the process of reviewing the CCPS Bylaws re: the assessment task force issue, it was discovered that the 2012 changes, approved by college faculty at the August, 2012 Fall Retreat, were never incorporated into the Bylaws. The CCPS Bylaws have been updated to reflect those approved changes.
