Comments, Proposal:

- Title and descriptors are very common. Spell out United States of America. Include "colonial period" in course description.
- "A historical analysis of crime and punishment in the United States of America from colonial to contemporary society. Addressing the evolution of criminal justice operations, policy, and change from historical perspective." Include this second sentence in the description of the course.
- It states that this course will serve as a foundation for other higher-level courses. However, it is an elective course, which means that it would not serve as a foundation for all CJ students. Replace with "Faculty workload will not be impacted by this new course because..."
- Will it be required for majors and minors, or remain an elective?
- This is a new course to the program there should be an impact on faculty workload.

Comments, SOR:

- Concerning the first objective, please update to state, "Develop student's or students' knowledge of crime and punishment.
- Mass incarceration continues to be a current issue since the early 90s; I would consider this a contemporary topic.

- First topic: can it be "introduction to the course"? This is not a topic per se. Topics need to be content specific.
- The SOR may need some adjustments in the first objective.
