- Title should be program specific and not school specific.
- Clarify student hours per week of participation.

- Clarify when the course is worth 3 credit hours vs. 9 credit hours. Give more specificity as to how the hours are distributed based on number of credits selected by students. Describe by activity how hours are distributed.
 - Clarify how the course aligns with unit goals.
 - SOR objectives 3, 5, and 6 could improve with better verb choices.
 - Clarify rationale for making this study abroad.
