Personnel Policy Revisions - Discussion (<u>Fall 2023 revisions</u> & <u>proposed CPC Language</u> Winter 2021)

- Feedback indicated dissatisfaction with revisions, as they do not address philosophical differences around inclusion
- Faculty from SSW in attendance at meeting requested use of university standards as a college with units drafting more specific standards
- o Concerns raised around the definition of leadership under service
- Concerns raised around perception of fewer service opportunities, specifically in light of reduction in university committee representation

Bylaws around Voting Procedures (proposed policy language)

- Reviewed policies and procedures from both former colleges to construct current proposed policy language

• FG Committee Name Change

- Proposal to change name of committee from the Faculty Governance Committee to the Faculty Council
- o Discussed rationale: Changing the name of the committee from the Faculty Governance Committee to the Faculty Council is a logical step for consistency and clarity across the university. The term "Faculty Council" better reflects the standardized nomenclature used for similar committees university-wide, avoiding potential confusion and aligning with the common understanding that governance encompasses a broader framework of activities and relationships, not solely the responsibilities of a single committee. That is, our Faculty Council will act as a body of representatives within our college governance structures.

- Conversation around M.Ed. requirements
 - A number of education programs over the past few years have asked about EDF requirements within the M.Ed., as these were established prior to 2006 (per COE faculty handbook). The Dean's office, in collaboration with EDF faculty, suggested faculty governance take this up.
 - Thoughts shared around creating a task force with faculty from education programs to review requirements and curriculum in efforts to update and ensure we are meeting student/program needs.
