Revisions to recertification policy	Director believes we need to have a policy for 3 things: 1) not submitting the data on-time, 2) not submitting the CAR on-time, and 3) not submitting an adequate CAR. She presented an edited recertification policy for the committee to review. Member suggested we say, "effectively assess" instead of "show progress" because some of the inadequately assessed courses did not even address GE objectives. Members discussed the wording of the policy and made changes as necessary. Members suggested that the recertification policy state that if the data and CAR are not up to standards, then the unit must reassess the next time the course is offered. If the CAR is inadequate but the data is good the assessor must submit a revised CAR in 15 days of notification from GEC.	Director will revise the recertification policy per the discussion and present it again at an upcoming meeting.
Approval of agreement with Honors	Members reviewed the agreement with no further discussion.	P. Thorpe moved to approve. K. McKee 2 nd . Motion carries 12-0.
Possible new question on the CAR	ECS suggested GEC add a qualitative assessment of student learning. Director stated that we could add a question to the CAR asking the assessors how the data matched their holistic interpretation of students' knowledge. Members suggested asking, "How well do you think the students met the SLOs for GE?" Member does not think that we need a question since it is not relevant to the data/information we are collecting.	Members agreed to not add this question.
(Start of) Discussion of interdisciplinary category (UAS charge to review foundations)	UAS charged GEC to review the Foundations category. Director stated that many colleges and universities have a component for Humanities in their GE program and we do not. Some courses that students are transferring in do not fit neatly into one of our categories. Director stated that we could change the categories around or add a credit neutral category. We must be careful about what we can do because staffing courses could be an issue. Member asked what the reasons for adding a new category would be. There are transfer students with courses that don't fit neatly in our program and interdisciplinary courses that don't properly fit into GE. Director stated we could add interdisciplinary courses into each category or create a whole new category strictly for interdisciplinary courses. Member stated it would be easier to create a new category that would be a substitute for some other GE requirement. Member asked if students are having a hard time graduating on time or if the interdisciplinary courses are helping the employer needs that Career Services discussed? No, students are not having a hard time getting through their programs in 4-5 years. All courses in GE are relevant to careers. Member asked if we take away our current requirement and add this interdisciplinary box, are we taking away something that students should be learning to help them in their major? Member asked how an interdisciplinary category would be assessed. Director said it would be similar to everything else but have its own set of interdisciplinary	Director will find a peer institution with IDS and share
