<b>Assessment Data</b>	Chair suggested we make a Table of Contents. Change color from skill to skill on Figure O.5 in the	
Report	Executive Summary and other figures that have a lot of bars. Members agreed that the apparent	
	trends in a lot of the graphs don't make sense. Why are Seniors doing worse than Freshman in some	
	skills? We need to explain why that is. We can explain that some professors are trained in	
	assessment and others are not and during training they are given a better understanding of the	
	scoring system. Member stated that we want to know if students are proficient or higher at	
	graduation as opposed to on a yearly basis. Chair stated we need to review the report, make	
	revisions, and then address the issues. Member stated that we have seen a lot of bad data, strange	
	assessments, etc. through the CARs which give us more information than this report. Member	
	stated that Figure O.5 covers three years of data so we can't know if there were improvements	
	from year to year. Chair stated that the report needs to state that the underclassmen in Issues was	
	due to Honors courses. Possibly take the Honors courses out of the graphs or add frequencies.	
	Members can send any comments to the Chair or to GE directly. Member asked who the audience	
	of this report is. Chair stated the GVSU Community. Interim Director stated that the Higher Learning	
	Commission would be another target. Member stated that the report is too hard to interpret for	
	such a broad audience. The narrative text in the beginning of the report stated there are no P	
	Values – that should be expanded upon. Also, need to express that there is some value in the data	
	but everyone assesses differently so the data can be subjective in areas. Members feel the data in	
	the Executive Summary is valuable but needs to be explained so that the general audience can

Agenda Items	understand and interpret it properly. If GE decides to distribute mini reports the committee thinks they should be distributed at the same time. However, the committee feels like the big report with a well-written and explained Executive Summary should suffice. Member stated that this document should be able to be read by the entire university community and should be simplified. There could be more small reports written for different audiences and from different angles. Interim Director stated that adding a discussion section to the report should be included for easier interpretation plus allowing for GE to explain what we learned and how we will make improvements. Chair asked if it is common to have a discussion section in an assessment report. If it is, how big of a role should the committee play in that? Interim Director will speak with the director and draft some ideas to share with the committee. Member stated wherever there is concern or good data we should note it and include in the discussion. Member stated that we should also include all the changes we have made already including the rubrics, how we give faculty instructions, etc. Member stated that it would be helpful to have frequencies in addition to percentages so we know how many Freshman	Action Taken
