CAR Reviews O BIO 311 O CJ 101	Chair stated that we want to keep our replies positive and thank assessors for taking the time to assess the courses and complete the CAR. If there are issues we offer them constructive criticism. The CARs for BIO 311 and CJ 101 were reviewed as a committee.	Chair will write reply letters and share with the committee.
Simplifying the skills rubrics	Regarding the concern that assessors wouldn't realize that a 4 is a possible score once the description is removed, the chair stated that we need to present the rubrics with accompanying instructions so assessors know they can give scores from 0-4. Member said it would be helpful to know why we are reducing words. Stated that the longer version gives more understanding to the expectations for a particular score. Chair stated maybe we are reacting to faculty perception to student reactions to the rubrics. Chair asked if we should keep the description for 2 or get rid of it and only have descriptions for 1 and 3. Member stated that the middle ground is the hardest to determine with student work. You can see when students are doing really well and really poor. The middle is the toughest.

	agreement on what needs to be done. Susan, Paola, and LeShell volunteer for Problem Solving. We	
	will review it as a committee next week, along with a few more volunteered revised rubrics.
