**Chair's Report** – No meeting next week because of MLK Day. Fall CARs are due from faculty on Friday. Chair met with a few faculty members regarding CARs and/or assessment procedures.

**Director's Report** – Assessment workshops started last Friday and will continue through this week. The director reminded faculty to get their assessment data and CAR done before summer break. The GE Program offered to cut the cost of the GE Handbook design and printing to save money as part of the cost-saving exercise. We are waiting to hear how to proceed. GE will no longer require Faculty-led Study Abroad students to take two courses from two different disciplines. They can be from the same discipline if taken abroad. The Director is retiring effective May 2026.
