Process for Requesting Issues Credit

- 1. Review the guidelines for the Issues Reflection Essay on the Study Abroad Issues Proposal Form (attached).
- 2. Write your Reflection Essay and complete the Study Abroad Issues Proposal form (attached).
- 3. Email the Issues Proposal Form and your Reflection Essay to gened@gvsu.edu within

60 days

after your return from study abroad. Hardcopy submissions will not be accepted.

Other Information

1. If the program offers two courses from the same discipline, you can use one study abroad course to count for Issues and the second Issues course must be from a different discipline taken at GVSU.

(Faculty-Led Programs ONLY)

- 2. Courses cannot count for both General Education Issues and Foundation credit.
- 3. Any 3 credit course completed abroad will automatically fulfill the Global Perspectives requirement, unless otherwise stated on the program flyer.
- 4. Independent study, independent research, and independent readings (XXX399 and XXX499) courses cannot be used to satisfy Issues credits.
- 5. If an Issues course taken on-campus is cross-listed in two disciplines, your second Issues course must be taken from a third discipline.

Study Abroad & General Education FAQ's

1.Am I required to obtain the GVSU course equivalency from each academic department for my study abroad courses before submitting my General Education Issues Reflection Essay and Study Abroad Issues Proposal Form to the General Education Office?

Yes. You must secure the departmental approval for each course you complete abroad before you can complete the General Education Issues Reflection Essay. All courses completed abroad are assigned a GVSU course equivalency by the relevant academic department. The course equivalency is a required field on the Issues Reflection Form. If the course you complete overseas has already been reviewed by the academic department, and the course equivalency is listed on one of the course equivalency charts available on the PIC website, you do not have to get that course approved by the department.

2. Can I obtain approval for my Study Abroad Issues prior to departure?

No. Students will not receive approval for the Issues requirement prior to studying abroad. The Study Abroad Issues Reflection Proposal Form requires a written Study Abroad Reflection Essay to be attached when you are requesting approval to earn credit for the Issues requirement.

- 3. How will I know if the course I complete abroad will fulfill the Issues requirement if I cannot request prior approval? The requirements for the Study Abroad Issues requirement are:
- □ The course(s) you complete abroad must be approved as a minimum of a 3-credit course at GVSU. It can be more than 3 credits, but it must be a minimum of 3 GVSU credits.
- □ The course cannot also fulfill a General Education Foundations requirement.
- □ If you are participating in a faculty-led program, or are taking less than 6 credits abroad, your two Issues courses must be from two different academic disciplines.
- □ Independent study, independent research, and/or independent readings are not eligible for Issues credit.
- □ Your Issues Reflection Essay and Issues Proposal Form must be submitted to the General Education office within 60 days after you return from your program via email.

4. Can I get credit for Issues and my major with the same course?

Yes. If the course you complete abroad meets major or minor requirements, it can also be used to meet the General Education Issues requirement.

- 5. Is it possible for me to earn credit for Global Perspectives, Issues and my major with one course abroad? Yes. With the appropriate approvals, you can earn credit for all three requirements with one course.
- 6. Can I submit my Study Abroad Issues Form electronically or by hardcopy?

You must scan your completed documents and send them by email to: gened@gvsu.edu. Hardcopies will NOT be accepted.

7. If I am completing a course abroad that will transfer back to GVSU as 6 or more credits, will this study abroad course fulfill my two Issues course requirements?

Yes. As long as the study abroad course is at least 6 US credits, you can request this course towards 2 General Education Issues requirements. Faculty-Led Program courses excluded.

8. I studied abroad through a previous institution before transferring to GVSU. Can I request approval for the study abroad courses from my previous institution to count towards the General Education Issues requirement?

Yes. You can request approval for these courses to meet the General Education Issues requirement, provided you complete the required Issues Reflection Essay and Study Abroad Issues Proposal Form.

9.1 participated in a COST program, does that fulfill my Issues requirements?

Partially. The COST programs fulfills 1 Issue course (reflection essay still required) and then you must take an additional Issue course before or after the program itself from a different discipline. COST programs do fulfill the General Education Global Perspectives requirement.

10. I participated in a faculty-led teacher assisting program, does that fulfill my Issues requirements? Partially. The faculty-led teacher assisting programs fulfills 1 Issue course (reflection essay still required) and then you must take an additional Issue course before or after the program itself from a different discipline. Faculty-led teacher assisting programs do fulfill the General Education Global Perspectives requirement.

STUDY ABROAD ISSUES PROPOSAL FORM

STEP 1 of 4 – Prepare a Reflection Essay

Select 1 of the 6 Issues topics listed below. Reflect on the entirety of your experience abroad which includes your course work and your experiences outside of the classroom (i.e., sight-seeing, mass transportation, lodging, encounters with other people in the country, buying food, etc.). You may select topics underneath the broader issue, just be sure to list both the Issue and the specific topic you are addressing. Only 1 reflection paper is needed to fulfill entire General Education Issues requirement (1 paper for both courses).

(1-2 pages, single spaced)

- 1. Describe the similarities in perspective on the <u>problem</u>, <u>causes</u>, and <u>potential solutions</u> to the Issue between the U.S. and the country you visited.
- 2. Describe the differences in perspectives on the <u>problem</u>, <u>causes</u>, and <u>potential solutions</u> to the Issue between the U.S. and the country you visited.

Once your reflection has been reviewed, you and Records will receive an email approval that will allow you to use the courses proposed to fulfill your Issues requirement.

Notice:

Courses taken abroad that are used to fulfill the Issues General Education requirement cannot be used to fulfill a General Education Foundations requirement. Students must choose between fulfilling the Issues requirement or fulfilling a Foundations requirement.
