Helpful Hints:

- ACC 250 must earn a C or better
- ACC 350 must earn a C or better
- All ACC 300/400 level courses must be passed with a C- or better
- School of Accounting Faculty discourage taking more than **two** 300/400 level ACC courses per semester if possible
- Recommend taking ACC 250 (3 cr) with ACC 213 (3 cr)
- **If only taking 1 tax course, students should take ACC 417/517**
- Students wishing to pursue CPA certification should meet with Faculty members for exam requirements

Please Remember:

- Courses that include 'GE' are required and fulfill a General Education requirement.
- Two (2) Supplemental Writing Skills (SWS) courses are required.
- Student must have a **minimum of 120 credits** to graduate with **58 of the 120 credits** being from a senior level institution and the **final 30 of the 120 credits** completed at GVSU.
- Students must have a 2.5 or higher overall GPA and a 2.5 or higher Seidman GPA to graduate.
- Students must have a 2.5 or higher Accounting GPA for the first 9 credits of 300/400 level courses to take new ACC courses.

Admission Requirements for BBA/MSA:

- 75 credits completed with at least 30 credits remaining at GVSU.

- Cumulative GPA of 3.25 or higher with the expectation to maintain that throughout the current semester.
