#### **Academy Description**

PrepNet Virtual Academy was created to provide an additional educational choice for two primary student groups with different unmet needs: I) those currently enrolled in an NHA partner school who desired a virtual option, and 2) others across the state who are interested in a rigorous academic program of study in a virtual setting. We seek to be a desirable choice for families across the state looking for unique ways to meet their child's educational needs. Students in K-6 experience rigorous academic instruction from a live classroom teacher throughout the day, with a focus on educating the whole child through moral focus curriculum in a safe and nurturing environment. Students in grade 7-12 participate in 7 courses daily, including an Advisory course, which includes moral focus curriculum and necessary soft skills ensuring students are well-rounded. Classroom courses exceed MI Merit Curriculum expectations and utilize a college preparatory experience to enrich daily learning and create life-long habits for success outside of school.



# CSO Capacity Analysis

PrepNet Virtual Academy continues to show academic, organizational, and fiscal soundness. Now in its fourth year, the academy has effectively managed a surge and subsequent stabilization in enrollment. This has been accomplished largely due to the experience, resources, and support by the school's management partner, National Heritage Academies. Organizationally, the academy has a solid management company, school leader, and academy board. From an academic perspective, the academy has strong instructional leadership and high-quality instruction in most classes. In total, the CSO has confidence in the academy's capacity to continue making academic gains for students. Significant efforts were placed to improve testing compliance. Test participation went from 52% to 61%.



Difference between the academy and statistically similar schools on M-STEP Proficiency, SAT Total Score, and Student Growth Percentile (SGP).




#### Student Growth Percentiles (SGP) Delta








