Our student body is extremely mobile due to the many challenges they face including poverty, housing, food, and job insecurity. These factors have a negative impact on our students' academic success. We exist to remove those barriers and help students achieve their diploma and establish a career path.

Highlights


Fully implemented a PBIS program with weekly and monthly rewards for meeting behavior and academic expectations.

Planned and executed several college and career field trips to assist students in creating post-secondary plans.

Improved access to social emotional learning through the implementation of the TRAILS curriculum in the classroom and partnerships with the Phoenix Center and MSU Extension.

CSO Capacity Analysis

Covenant High School East is fiscally and organizationally sound and continues to proactively address the academy's challenges with innovative alternative educational goals. Increased student engagement and access to social-emotional learning through the implementation of the TRAILS curriculum in the classroom have led to higher graduation rates. In addition, the implementation of a PBIS program has increased incentives and rewards for positive student behavior. The Charter Schools Office (CSO) has observed the school leader, superintendent, and academy board have diligently worked to uphold the mission and vision of the academy while significantly enhancing student outcomes. The academy has expanded its programs, including the introduction of Career Exploration initiatives, to better meet the diverse needs of its students. Additionally, to support both in-person and virtual learners, the academy has increased its staff, ensuring students receive the necessary guidance and instruction. The CSO has also noted the continuous efforts to attract and retain highly qualified staff, with salary increases and paid time off opportunities. The CSO is confident the combined support and resources provided by the academy board and school leadership will enable the academy to continue enhancing student outcomes while maintaining its integrity and commitment to its mission throughout the remainder of its current charter contract term.

Educational Goals (Schedule 7-1) and Evaluation

Phases: Each student enrolled at the school shall annually (Fall and Spring) be classified by the school based on the phase of learning that the student is in.

Fall-Spring Phases



Phase 0: *Student has enrolled at the school, but has little to no live attendance (<20%).*Student has either not engaged or has minimally engaged in the school's online course platform, if any.

Phase 1: *Student sporadically attends the school (20-65%).
*External barriers sometimes negatively affect academic success.

Phase 2: *Student regularly attends the school (66% or more). *Student is earning credits at a pace of 4 credits/year or more. *Student regularly engages in and completes coursework through the school's online course platform, if any. Student exhibits positive behaviors, mindsets that align with academic success regardless of external barriers.
