### CSO Capacity Analysis

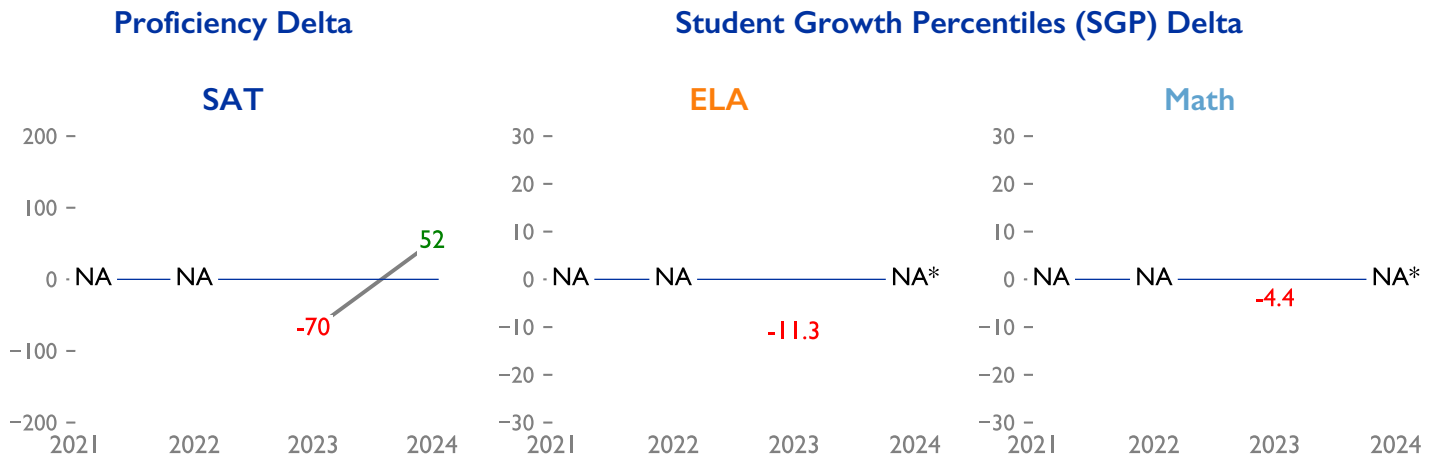
The Greenspire High School, serving grades 9-12, has demonstrated organizational and fiscal viability as well as academic proficiency improvement. The Charter School Office (CSO) observed the academy maintained strong enrollment and continues to be an attractive option for area families, especially given its strong programming in project-based curricula, early middle college options, and environmental foci. The academy does not meet its compliance but meets financial reporting measures from the CSO while maintaining a positive fund balance. The academy has been proactive to support student learning and to align practices with the middle school campus. School leadership is coordinating efforts to create seamless educational experiences for students in the district. The CSO is confident the academy has the capacity to achieve their educational goals and improve compliance reporting.

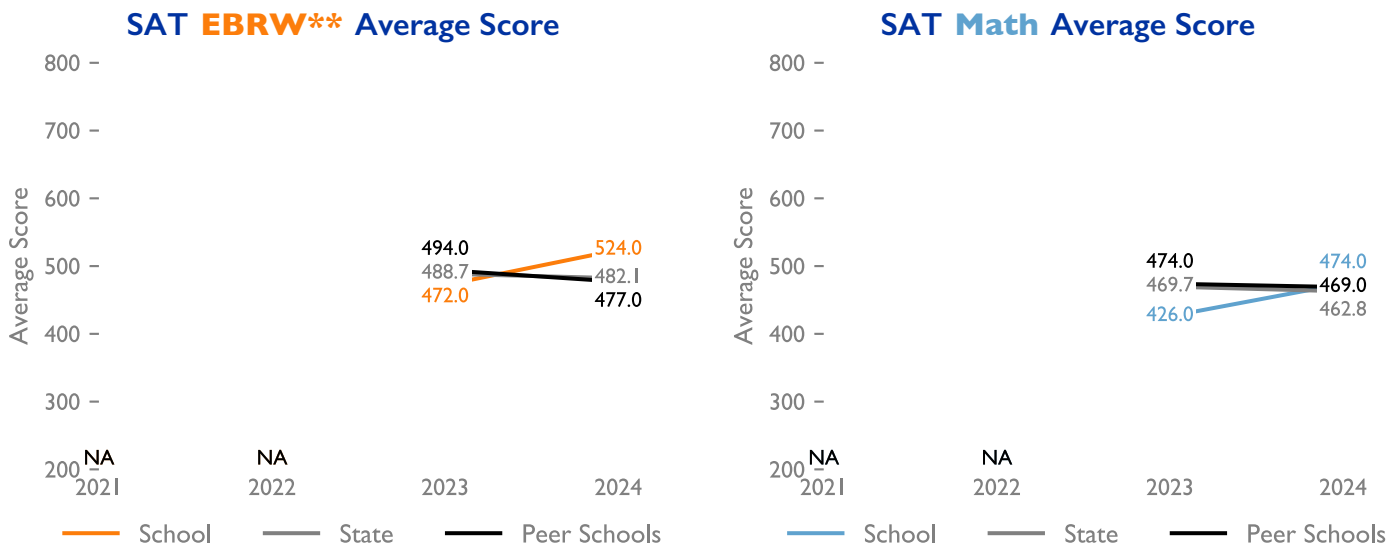

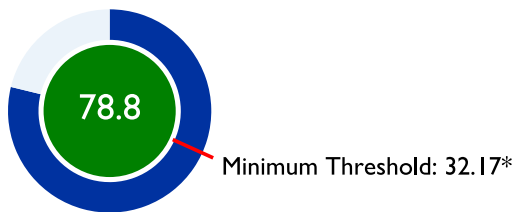

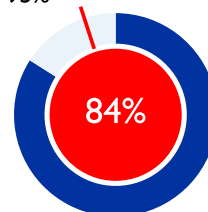

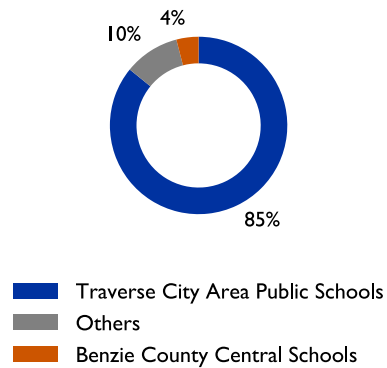

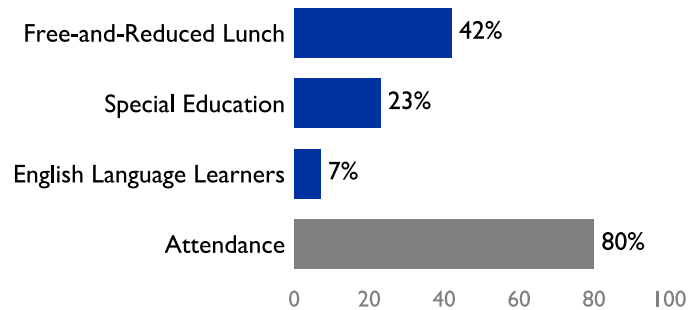

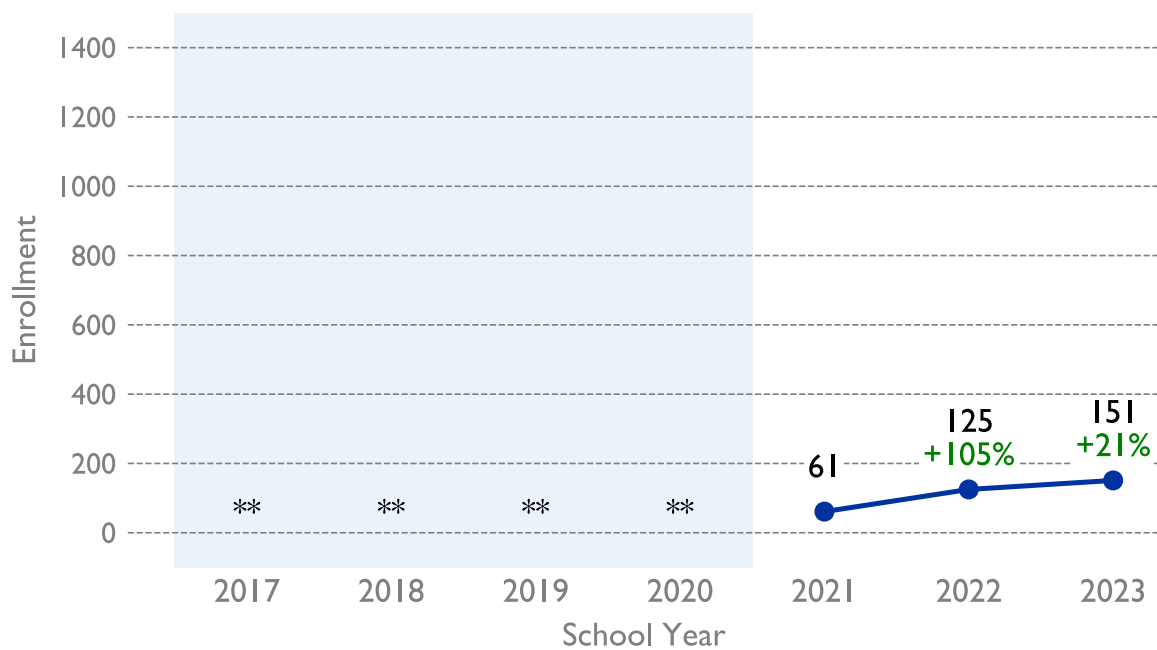
### Student Resident Districts



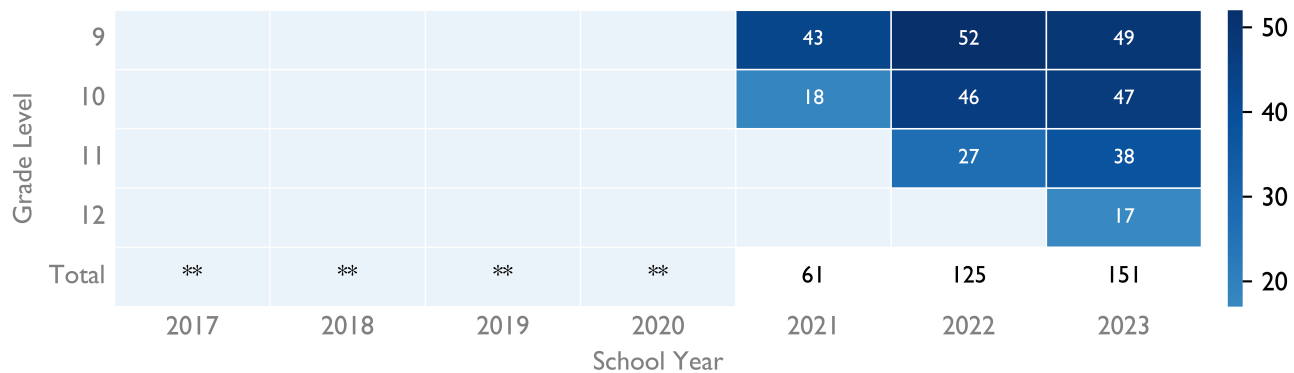
### Subgroup Enrollment and Attendance
