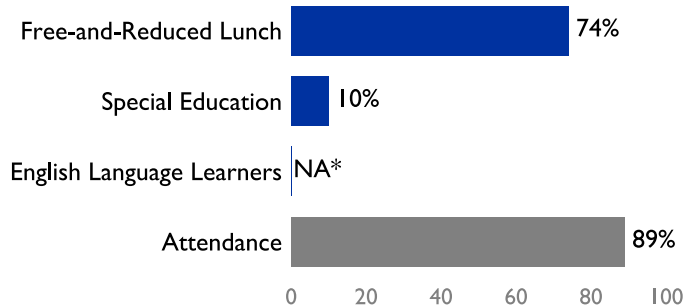

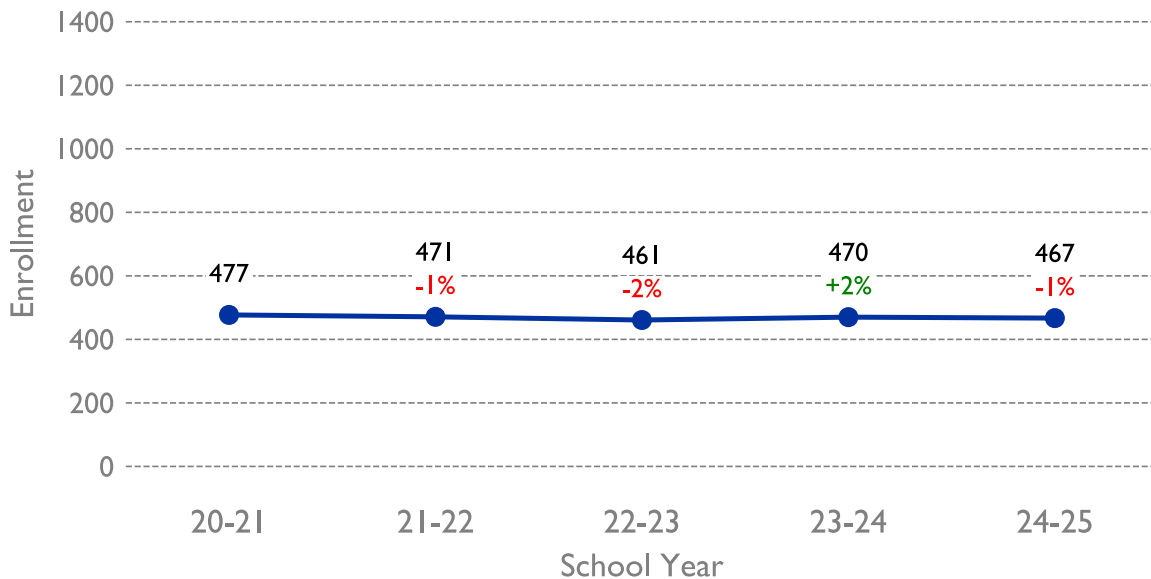

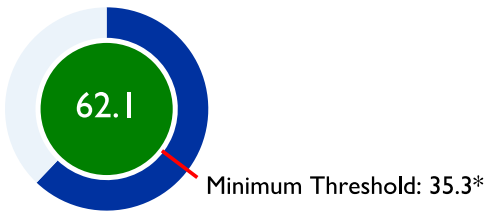

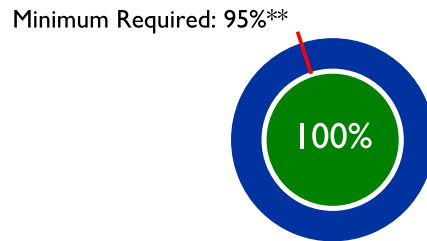

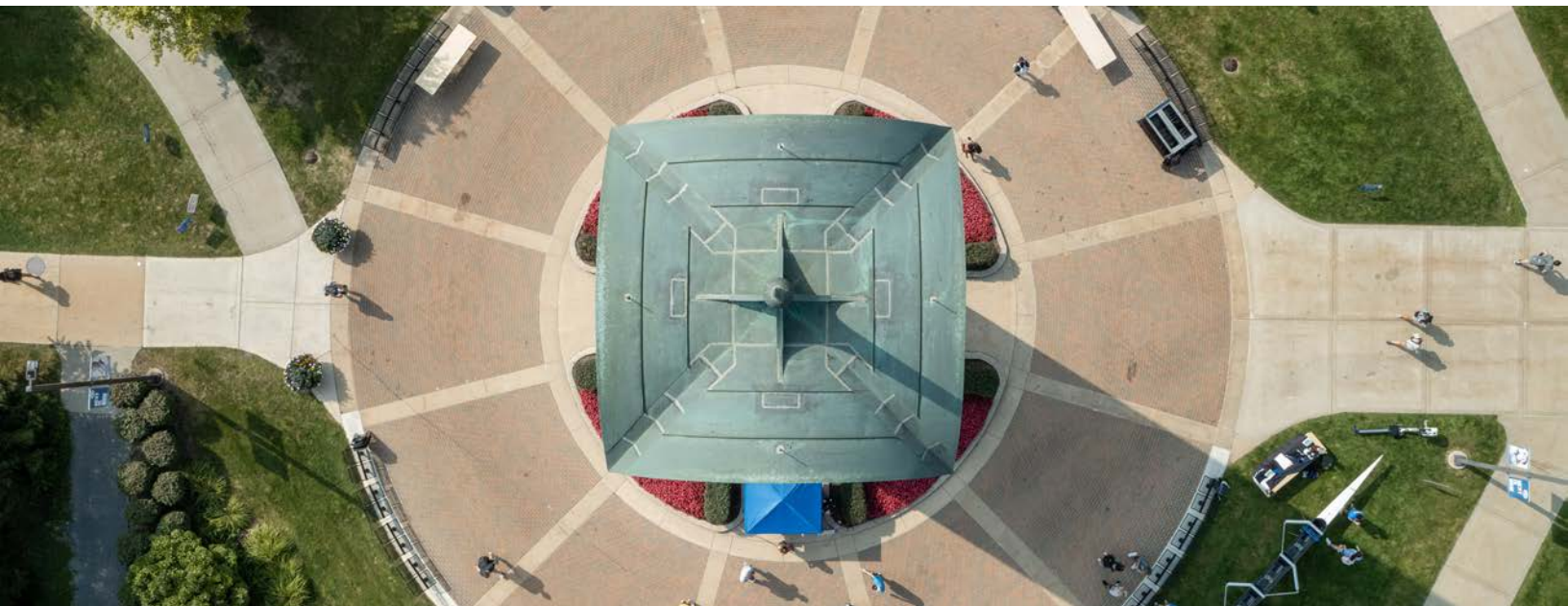

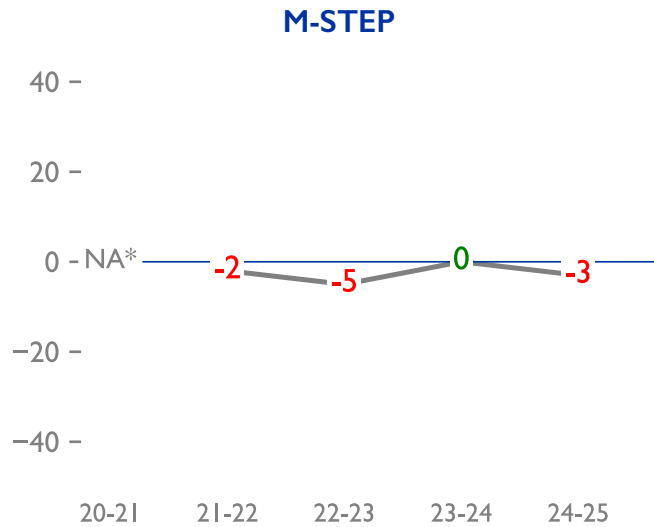

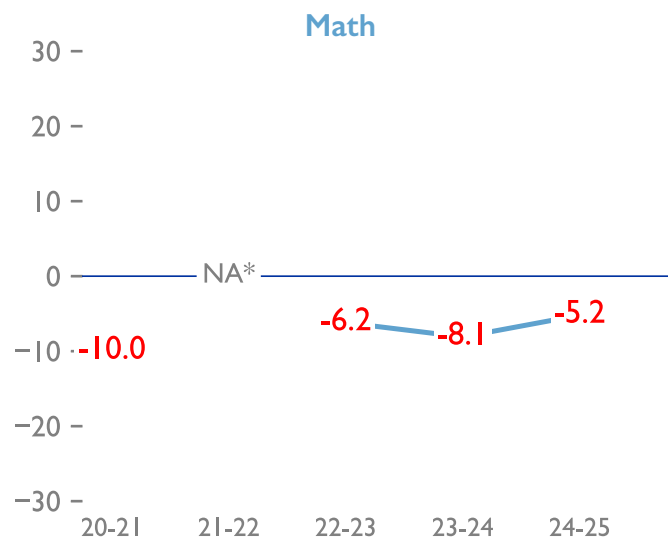
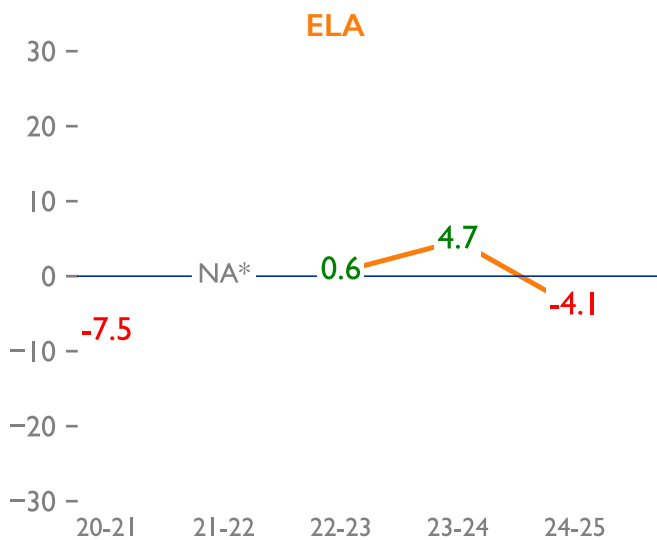
### Charter Contract Academic Performance Trends

### Achievement Performance Compared to Peer Schools Over Time



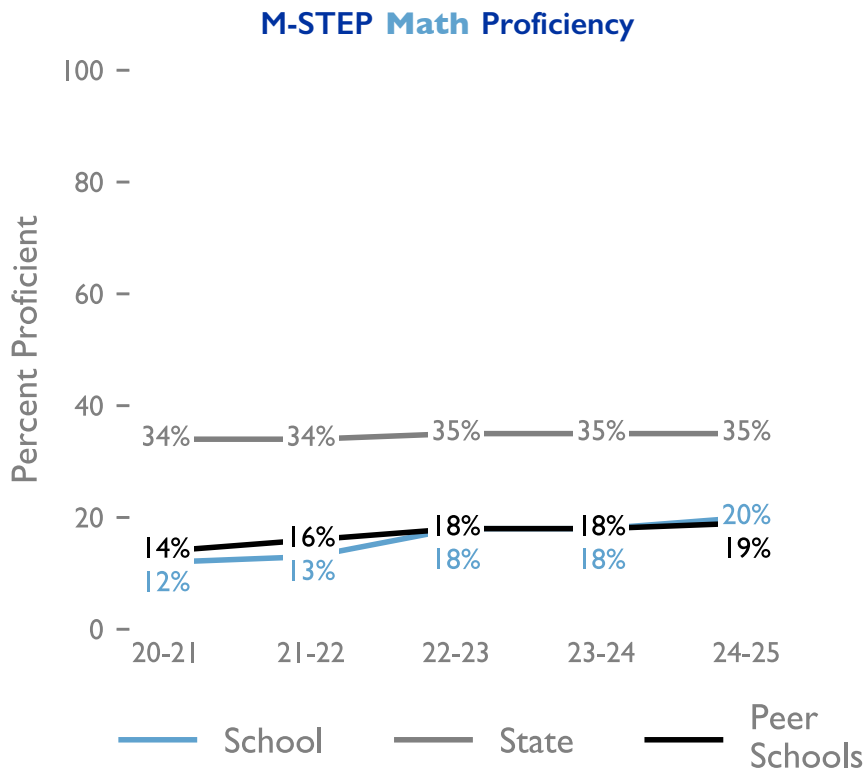
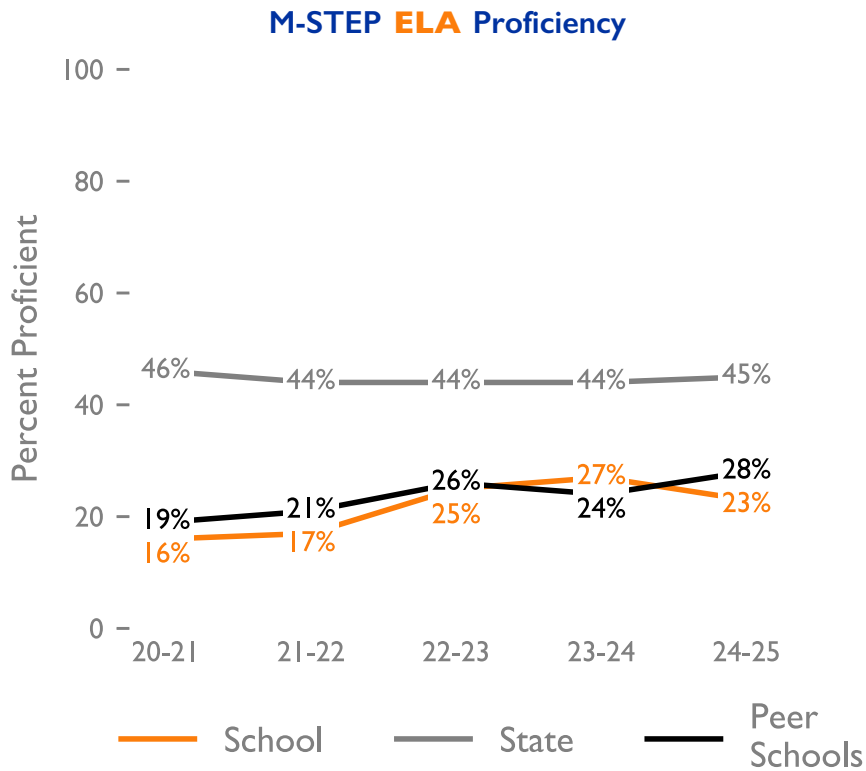
### Growth Performance Compared to Peer Schools Over Time
