

Psychiatric Mental Health Nurse Practitioner Certificate Program Podcast

Hello, my name is Aruna and I am a staff member in The Graduate School at Grand Valley State University. Thank you for taking the time to learn more about Grand Valley's Psychiatric Mental Health Nurse Practitioner Graduate Certificate program. Today we're going to cover the admissions process, program requirements, and the qualities that distinguish this program.

Let's start by explaining what this program entails. The Psychiatric Mental Health Nurse Practitioner Graduate Certificate program is designed to prepare nurse practitioners to provide advanced mental health treatment to individuals with mental health disorders. PMHNPs are in high demand and are uniquely qualified to fill the workforce gaps in the mental health system and have an important perspective on both the physical and mental health needs of people seeking quality care. Courses focus on growth and development across a person's lifespan, psychopharmacology, theories of mental health and personality, treatment modalities (individual, group, and family), and practicum experiences. The hybrid format is ideal for working adults through online coursework and high impact in-seat classes. Coursework includes 22 credits with 750 clinical hours.

Standard Grand Valley admission requirements include completion of the online application as well as a Bachelor's degree from an accredited institution of higher education. Your application must include official transcripts, and if English is not your native language you must provide scores from one of our approved standardized tests such as the PTE Academic, TOEFL, IELTS, or Duolingo. There is a \$30 nonrefundable application fee, however, this fee is waived if you attended Grand Valley previously or are currently attending Grand Valley.
