## **GVSU RFP #219-29: Instructions**

- 1. Provide a proposal for both a **purchase price** AND **36 month and 48 month lease** of one brand new crew cab pickup truck per below specifications. Include any rebates and incentives. On the lease quote, state net gross capitalized cost, rent, **interest rate**, and residual.
- 2. GVSU vehicle fleet numbers: GM 000918139 (Govt) Ford QI 363 (Govt) Ford VK094 (Commercial)
- 3. Quote F.O.B. delivered to Grand Valley State University, Allendale Campus
- 4. State all the standard and optional specifications/features that are included in your quote. Successful supplier will be responsible for order verification and specifications accuracy.
- 5. Provide full information on the vehicle manufacturer's and major equipment warranties.
- 6. State ALL upfront costs including any security deposit and first month's payment (but excluding taxes and registration fee)
- 7. State the residual value at lease end and lease end cost to purchase if GVSU wishes to.
- 8. State if there is a disposition fee on the lease (fee if you turn the vehicle in without leasing another vehicle from you).
- 9. State the availability of your vehicle. GVSU must take possession of vehicle no later than Monday, xxxxxx. Time is of the essence. State if your proposed vehicle is from dealer inventory or factory order.
- 10. Is your proposed vehicle available for test drive?
- 11. GVSU reserves the right to inspect, test drive, and general approval of vehicle prior to acceptance.
- 12. Please provide two West Michigan customer references including names and contact information for who have same or comparable vehicle to the one you are quoting
- 13. Successful supplier will not be allowed to display dealer sticker on vehicle. Vehicle must be free from all dealer advertising/promotional decals
- 14. Grand Valley State University is Michigan sales tax exempt. Exemption certificate will be provided to the awarded supplier.
- 15. GVSU will provide its own license plate. Dealer does not need to provide.
- 16. Grand Valley State University reserves the right to accept or reject any or all proposals.
